CSRS Retirement System Specific

The CSRS retirement seminars are for Federal workers who were employed before 1983 and remained in their original retirement system. Civil Service Retirement System (CSRS)-Offset employees should go to the CSRS seminar. CSRS employees who transferred to the Federal Employee Retirement System (FERS) should go to the FERS seminar; benefits related to any CSRS service will be discussed. If you have a spouse you should consider bringing them to the seminar, there is a reduced rate for spousal attendance. **ATTENTION: All attendees must download and print out the course handout posted on homepage of the FEB website www.minnesota.feb.gov. Bring this handout with you to the class.**

FERS Retirement System Specific

Federal Employee Retirement System (FERS) covers Federal workers hired on or after 1983.
