### Modernization Activities Wing 3

**Wing 3**

**7th Floor**

**East/West**

- Plaster patching
- Lead abatement of FCU's ,fire stopping etc.
- Install 5 pipe system at exterior shafts, test 5 pipe system and insulate 5pipe system
- Sprinkler pipe rough-in at offices
- Soffit and shaft close-in inspections
- Close in walls and shafts
- Install CMU privacy wall in restroom/wall patching

**6th Floor**

**East/West**

- Plaster patching and texturing ceiling
- Lead abatement of FCU's, etc. and fire stopping
- Soffit and shaft close-in inspections and Close-in walls and shafts
- Install exterior shaft pipes, conduit and duct
- Sprinkler pipe rough-in at offices
- Install window
- Install CMU privacy wall in restroom/wall patching
- Repair windows, paint windows and install window frames
- Sprinkler pipe rough-in at offices

**Mechanical- Floor**

**East/West**

- Secure area with monitors, card readers
- Insulate HVAV duct and pipes
- Painting exterior ornamental grills
- R/I Fire alarm conduit
- Install MEP pipe/duct/sprinkler test mechanical pipe mains

**5th Floor**

**East/West**

- Plaster patching
- Lead abatement of FCU's, etc.
- Install 5 pipe system at exterior shafts
- R/I lighting conduit
- Sprinkler pipe rough-in at offices
- Install windows

**4th Floor**

**East/West**

- Framing soffits, shafts, plaster patching
- Install exterior insulation
- Install 5 pipe system at exterior shafts
- R/I lighting conduit

**3rd Floor**

**East/West**

- Install exterior insulation
- Remove left over debris
- Framing soffits, shafts, plaster patching
- Install exterior insulation

**2nd Floor**

**East/West**

- Install exterior insulation
- R/I lighting conduit

**1st Floor**

**East/West**

- Remove left over debris

**Cafeteria**

- ACM preps and minor demolition

**Elevator 13/14**

- Removing old elevator equipment for renovation
