Aloha Gentlemen,

My name is James David Kimmel and I am writing you to augment my testimony given at the recent Reconciliation Hearings on Maui. I was born a United States citizen but I am now a citizen of the Lawful Government of Hawaii. My children from my first wife are great-great-grandchildren of G. P. Judd and great-great-grandchildren of A. S. Hartwell. The former assisted King Kamehameha draft the first Constitution that made Hawaii a Constitutional Monarchy; the latter was purportedly the lawyer that drafted the Articles of Abdication the Queen, Liliuokalani, was forced to sign under threat of bloodshed. He then became the Chief Justice of the Supreme Court of the new and illegal de facto government of Hawaii.

When I first discovered these facts and learned about the overthrow of Hawaii from the Queen's book, *Hawaii's Story by Hawaii's Queen*, I was shocked and vowed to do as much as I could to help correct the consequences of this great wrong. At this time I would like to respectfully protest the presence of your Reconciliation Committee in Hawaii because it is actually undermining the only legal recourse open to the Hawaiian People for the reinstatement of their Lawful Government of Hawaii as a function of their moral right and legal duty. If the U. S. Government is honestly and sincerely interested in the reconciliation of its unlawful actions then you are legally and morally obligated to accept and facilitate the process of the full reinstatement of the Lawful Government of the Kingdom of Hawaii. The de facto State of Hawaii and the de facto Government of the United States should seriously begin to address the task of vacating the premises of the de jure Government of Hawaii on August 21st of the nearest possible year.

The illegal overthrow of the Lawful Government of Hawaii is just One Boxcar in a Long Train of Abuses of Power and Usurpations of Rights, betrayals of trust pursuing invariably the same object, evincing a design to reduce the People under absolute Despotism. The Official Apology of the U. S. Government and President Clinton is a step in the right direction toward the Righteous resolution of this gross violation of the Golden Rule of Living, the U. S. Constitution and the Law of Nations. This could be an integral part of the Providential Adjudication of the consequences of the Lucifer Rebellion on the human level and the implementation of World Peace under the Law of a new form of democratic and representative World Government of the People, by the People and for the People of the World.

The Official Protest which Queen Liliuokalani gave to President McKinley began

with an acknowledgement of the will of God and the grace of God and closed with her declaration, ...to the Almighty Ruler of the Universe, to Him who judgeth Righteously, I commit my Cause. This is the same Person referred to in your Declaration of Independence as *their Creator* and *the Supreme Judge of the World* and in your Holy Bible as Jesus of Nazareth. This same Person, who I am commissioned to represent, is the Sovereign Co-Creator of the Universe of our residence and the Prince of Peace of this world. It is most important that we consciously bring the Prince of Peace into these proceedings because he is the Supreme Arbiter between any two or more persons or nations or worlds in His Universe. He is our Creator Father and it is most important for the people and Governments of this world to become increasingly truth coordinated and love dominated if we are to survive as a group. You and I and every other man, woman and child in Hawaii, the United States and the world are sons and daughters of God. Each of us have been endowed by our Divine Parents with personality, spirit and mind specifically designed to go with the mortal physical bodies provided by our human parents. We are self-conscious personalities in possession of the power to choose between good and evil, right and wrong, truth and error, relative perfection and relative imperfection, the will of God or the will of man. Each of us have been endowed with one quantum unit of political sovereignty and spiritual free will. We are equal, spiritually, and we are of infinite value to our Divine Parents.

Our common older human brother, Jesus of Nazareth, the Prince of Peace, would like to see things become more the way they ought to be on earth for the benefit of all of his mortal children. We all share and are personally related to the same spiritual Father, *GOD*, the Universal Father. In fact, the spiritual brotherhood of all humankind is predicated on the recognition of the Fatherhood of God. And what we need more than anything else in today's world is a new form of representative world government. Under a Master Charter of Liberty derived from a global Constitutional Convention every man, woman and child on earth would rise to the level of personal spiritual and political equality; every nation on earth would rise to the level of political equality with every other nation on earth.

The People and the de Jure Government of Hawaii want to see Peace on earth and Good Will among *all* men. We live and pray for a worldwide realization of the Fatherhood of God and the brotherhood of man; for the spiritual transformation of present-day humanity and the political organization of the spiritual brotherhood under the sovereignty of the Government of all Humankind. Concomitant with the coming of World Government is the need for some Place to serve as the Capitol of the Government of the People of the World, and Hawaii is ideally situated to serve the interests and needs of all humankind as the Aloha Capitol of World Peace and World Government in today's world.


It would be considered an act of Righteousness consistent with the will of God and the Law of the Universe if the United States Government would do all things possible to facilitate the reinstatement of the Lawful Hawaiian Government and the convening of a Global Constitutional Convention in Hawaii for the purpose of creating a Master Charter of Liberty for the benefit of every person on earth, for the greatest length of time and the glory of God. The U. S. Government would not be giving up de facto sovereignty over Hawaii as much as it would actually be assisting in the creation of a real, bona fide, and lasting world sovereignty which will henceforth be fully able to

protect them from all war. Collective security affords peace when the collectivity includes all humankind. Local affairs will be handled by local governments; national affairs; by national governments; international affairs will be administered by global government. World law must come into being and must be enforced by world government—the sovereignty of all humankind. It would be the attainment of the motto of the U. S. Government, *E Pluribus Unum*, on a global level.

The United States might be a nation that began under God, but is is also one that has become increasingly unGodlike in its acquisition of Territory and its mistreatment of People. The train Uncle Sam has been driving has been derailed and is heading in the wrong direction. It is time for Uncle Sam to return the Stolen Horse to its proper pasture as a natural follow-up for a sincere Apology. It is time for Uncle Sam to seriously consider withdrawing to its more Lawful Position before signing the Treaty that created the United Nations when Alaska and Hawaii were considered to be non-self-governing Territories. It is time for Uncle Sam to get Right with God.

Think about it! If we were big enough and bad enough to do unto you as you did to us wouldn't you want the horse back if we saw the light and apologized for our mistake? What all this proves is that Might does not make Right, but it has made what is. To make things the way they ought to be on earth, consistent with the Laws of the Universe and the will of God, Love and Truth make Right, Love and Truth bring mercy and justice. Only love, brotherhood, will prevent the strong from oppressing the weak. All men are the sons of God and by faith they can actually realize, and daily experience, this ennobling truth. The kingdom of God is the will of God, dominant and transcendent in the heart of the believer. The kingdom of heaven is a spiritual relationship between God and man and *within* the minds of men. To submit your will to the will of God is to allow the sovereignty of God to prevail, the sovereignty of Aloha—Love and Truth. The will of God is the law of God and he has mandated that all of his children should be perfect, even as he is perfect. The will of God is the way of God and with God, everything is a matter of freewill choice: you get just what you choose. Our main task is to be relatively perfect even as we become increasingly perfect each day in service to the human brotherhood. The act is ours, the consequences, Gods.
