My Name is Wayde Lee and I'm Native Hawaiian and a Homesteader LOT#65
I'm here to testify in behalf of my family Antone Slyia and Kawila Slyia who was one of the
Hawaiians who sign the protest in 1932 to extended diplomatic recognition to the Provisional
Government that was formed by the conspirators with out the consent of the Native Hawaiian
people. ...ect which is stated PUBLIC LAW 103-150 Nov. 23, 1993, paragraph 8 which was
recognize by United States Minister John L. Stevens . Also stated , United States recognized the
independence of the Kingdom of Hawaii stated in Paragraph 3 and paragraph 6,8 showed a act of
war that the United States invaded the Native Hawaiian People or Lawful Government of
Hawaii...ect and where as paragraph 9 our Queen Liliuokalani protest against the illegal act of
over throw to the Provisional Government but yield to the united States to the time they see fit to
reinstate The lawful Government of Hawaii. Where as: Paragraph 29 states: Where the
indigenous Hawaiian people never Directly relinquished their claims to their inherent sovereignty
as a people or over their national lands to the United States , either through their Monarchy (
Which I stated in Paragraph 9) or through plebiscite (which I believed doesn't matter) or
referendum. (which we also had). Now brings us to last step Reconciliation.

My family protest this Reconciliation but recognized this as a good time for KukaKuka.
Maybe even Ho'oponopono, with the United States. Not to sit at the table speaking to each other
from Nation to subject but Nation to Nation. I believed that we God fearing people and want to be
Pono in dealing with the United States That I personally Love and I Know that they United States
are just like us Children Of God and need to bring the truth to our people that they may able to be
guided by our ^{Father in heaven to make} Pono to resolve this matter. I believed their should be no dead line to this just
by the Countries that were Reinstated in the 20th century. For example 1997 Republic of Congo,
Hong Kong reinstated back to China, 1994 Former Soviet Union Republics that had 9 nations
reinstated. 1993 Baltic States - Lithuania, Estonia and One half part of the reinstatement process
By Public Law 103-150.

1949 State of Israel is reinstated after 1,800 years, 1946 After World War II the occupied
territories by Germany, Italy and Japan were all reinstated. ALSO Poland , Norway, Holland ,
Belgium, Yu/go/salvia, Czechoslovakia, Greece, Ethiopia, Philippines. You Know their were
