I. SPECIAL CONDITIONS

GENERAL CONDITIONS

- a. The use and occupancy of the property shall be without cost or expense to the General Services Administration, and under the general supervision of the Regional Administrator, General Services Administration, or his authorized representative, and subject to such rules and regulations as he may prescribe from time to time.
- b. The permittee shall at its own expense and without cost or expense to the General Services Administration, maintain and keep the property in good repair and condition.
- c. The use to be made of this property shall be limited to that specified in this permit.
- d. The permittee shall pay the cost, as determined by the Regional Administrator, General Services Administration, or his authorized representative, of producing and/or supplying any utilities and other services furnished by the General Services Administration for use of the permittee.
- e. No additions to or alterations of the property shall be made without the prior consent of the Regional Administrator, General Services Administration, or his authorized representative.
- f. On or before the date of expiration or termination of this permit, the permittee shall vacate the premises, remove its property therefrom and restore the premises to a condition satisfactory to the General Services Administration. If, however, this permit is revoked, the permittee shall vacate the premises, remove its property therefrom and restore the premises as aforesaid within such time as the General Services Administration may designate.
