When retrieving your transit media, you must present your Departmental Identification Card to the Department of Transportation (DOT) agent and sign a Transit Benefit Certification form.

If you miss the distribution date, you have three options:

- 1) You may acquire and complete the "Authorization for Third Party Pick-Up of Transit Subsidy" form, available in room 1210-Main Interior Building (MIB).
- 2) You may come to the **make-up day which is scheduled for Wednesday, June 16, 2004**, from 11:00 a.m. to 2:00 p.m. in the MIB cafeteria.
- 3) You may go directly to DOT headquarters building located at 400 7th Street, SW, Plaza Level in Room 206, from 8:30 a.m. until 4:00 p.m., Monday through Friday on government workdays.

NEW ENROLLEES: You may apply for the benefit any time during the year. To obtain an enrollment form and/or get additional information about the program, visit the Office of Financial Management web site at <http://www.doi.gov/pfm/subsidy.html> or contact your bureau or office coordinator. Enrollment generally takes five working days from DOT's receipt of your application. If your enrollment does not coincide with the quarterly distribution, employees will be able to pick-up transit media from DOT.
