Dear Ms. Young,

The 21st Century Integrated Digital Experience Act (the Act), Public Law (P.L) 115-336, requires the head of each executive agency (that maintains a publicly available website or digital service) to submit a report to the Director of the Office of Management and Budget (OMB) which includes:

- a list of websites or digital services maintained by the executive agency that are most viewed or utilized by the public or are otherwise important for public engagement;
- a prioritization of the list of websites and digital services that require modernization to meet the requirements of Section 508 of the Rehabilitation Act of 1973 as amended;
- an estimate of the cost and schedule of modernization for the websites and digital services prioritized; and
- the status of website modernization activities.

The Department of the Interior (DOI, Department), Office of the Chief Information Officer (OCIO) and Office of Communications (OCO), with input from the DOI Web Council, identified 22 departmental websites that are most viewed or utilized by the public or are otherwise important for public engagement.

- This list includes the Department's High Impact Service Providers: Bureau of Indian Affairs (BIA), Bureau of Trust Funds Administration (BTFA), U.S. Fish and Wildlife Service (FWS), and National Park Service (NPS).
- Of the 22 departmental websites identified, 11 are fully modernized; 1 has been modernized with increasing progress toward Section 508 compliance, 6 are currently undergoing modernization activities; and 4 are scheduled to be modernized in the future.
- Costs of modernization include upgrades to the most current content management system software.

In accordance with the Act, a summary table of the Department's most utilized public website information, and a detailed status of DOI's web site modernization activities are enclosed.
