Subject: Preparing a Decision Memorandum When Using the Department's Categorical Exclusions

for Hazardous Fuels Reduction or Fire Rehabilitation

#### **PURPOSE**

This memorandum supplements 43 CFR 46.210 for categorical exclusions (k) and (l) only. These two categorical exclusions were established in 2003, in coordination with the U.S. Department of Agriculture Forest Service (Forest Service). In Sierra Club v. Bosworth, 510 F.3d 1016, 2007 U.S. App. LEXIS 28013 (9th Cir., Dec. 5, 2007), the Ninth Circuit determined, in part, that the Forest Service's establishment of the hazardous fuels reduction categorical exclusion constituted establishment of a program for which a cumulative effects analysis was required. Because this litigation involved a categorical exclusion that is analogous to a categorical exclusion used by the Department at 43 CFR 46.210(k), the Department has determined that the categorical exclusion in question will remain in the regulation, with the understanding and written direction that it will not be used by the individual bureaus in areas within the jurisdiction of the Ninth Circuit.

#### **PROCEDURE**

When applying these categorical exclusions, bureau and office field managers must prepare a decision memorandum containing the elements of the Department's template to support the use of these categorical exclusions. This memorandum *does not* supersede bureau-specific guidance on the appropriate use of categories (k) or (l). Bureau personnel are directed to follow their own bureau-specific guidance concerning categories (k) or (l). Bureau or office checklists or other existing documentation may be used in conjunction with the template. However, any changes from the attached template must be approved by this office.

The Department's decision memorandum template is attached below.
