

# BISON FILE & SERVE QUICK GUIDE FOR REQUESTING TO JOIN AN EXISTING CASE



This Quick Guide outlines how users can request to join an existing case pending with the Office of Hearings and Appeals via Bison File & Serve.

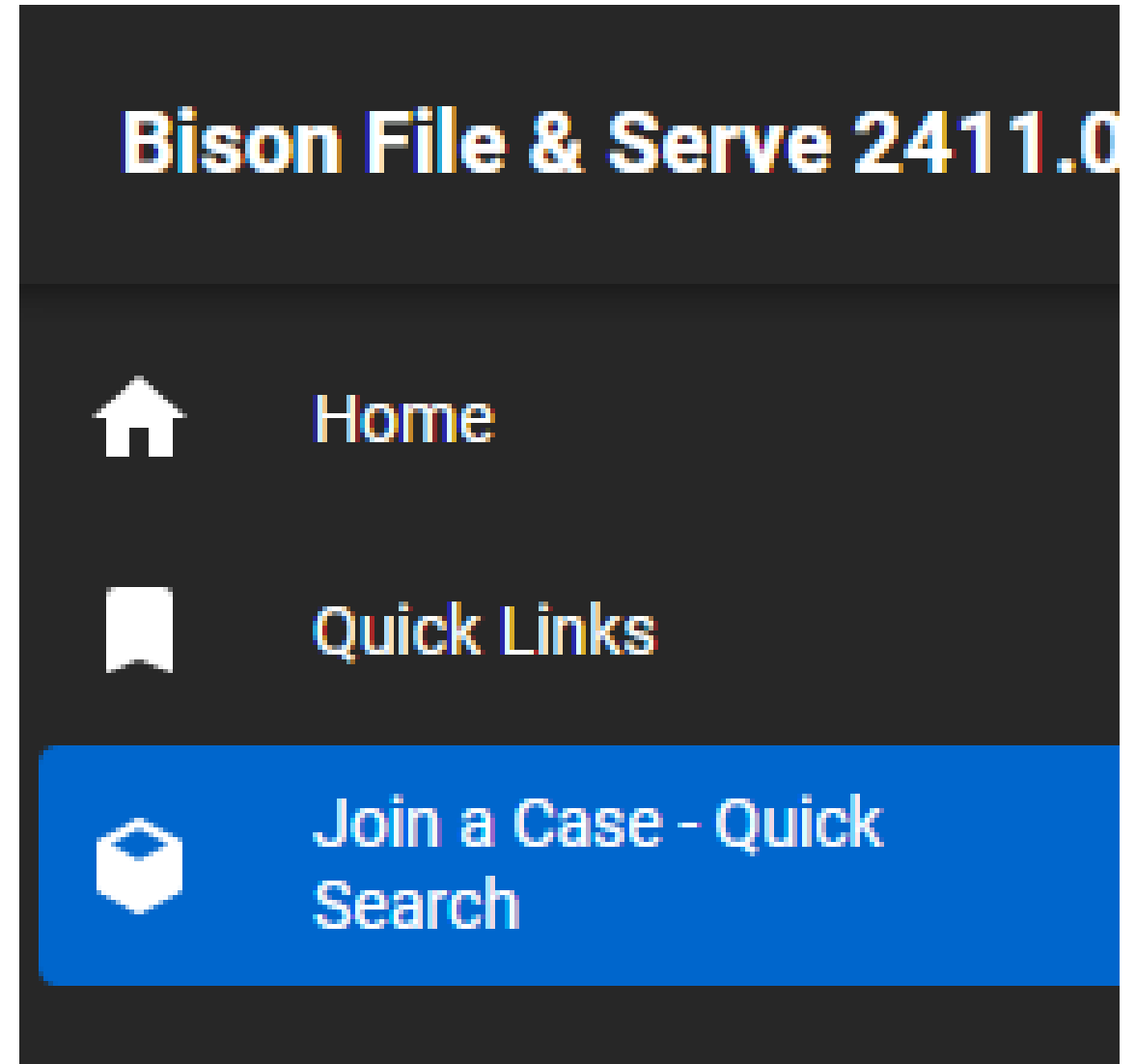

## Requesting to join an existing case

---

- With certain unit-specific exceptions, registered users of Bison File & Serve (BFS) can join existing cases to file documents with OHA, serve documents on other interested parties, and receive service of documents and notice of orders and decisions issued by OHA through BFS.
- To begin, log in to BFS and click on “Join a Case – Quick Search” in the menu to the left of the screen.



To search for a case, select the OHA unit and enter a date range for when the case was originally submitted to OHA. The date range may be as broad or as narrow as you like.

You should also enter any other information you know to filter the results, such as the docket number, case name, or date of the decision being appealed.

OHA uses Bison File & Serve to receive official filings electronically in lieu of paper filings. Sending a document directly to an OHA unit via e-mail, rather than through Bison File & Serve, does not constitute electronic filing unless otherwise specified by that unit.

Documents filed electronically must be transmitted by 11:59 pm Eastern Time (DIR, IBLA, IBIA), by 11:59 pm Central Time (WELSA), or by 11:59 pm Mountain Time (DCHD) on the day the document is required to be filed with the applicable OHA unit to be considered timely filed.

- Select a Proposed Party Type from the dropdown list. Your Proposed Party Type identifies your interest in the case (i.e., Representative, Party in Interest, Proposed Intervenor, Proposed Amicus Curiae, etc.)
- Note for IBLA cases: If you are joining a case in which you are already participating, then you can select your existing Party Type. If your Party Type is not included in the dropdown list, then select “Other.”

If the Proposed Party Type you selected requires documentary support, a red asterisk will appear next to the Case Documents field.

Click on "Upload New Document," fill in the required fields, and click "Save" to add your document to your request to join the case.

**Note for IBLA cases:** If you are already participating in the appeal, then upload a document that notifies IBLA and other parties that you have joined the case via BFS and provides parties who do not use BFS information on how to serve you.

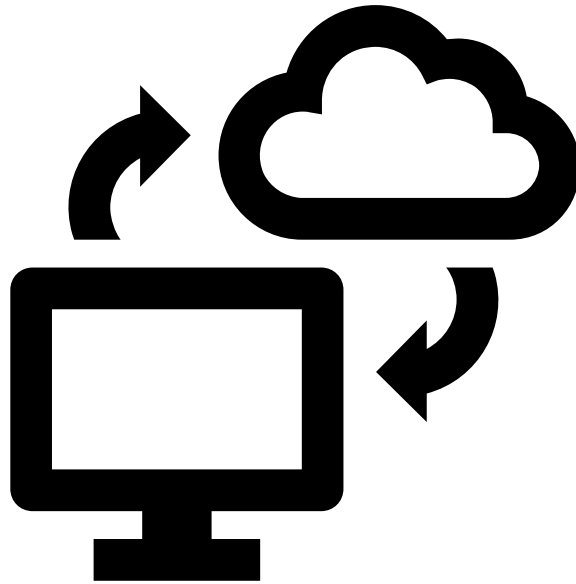

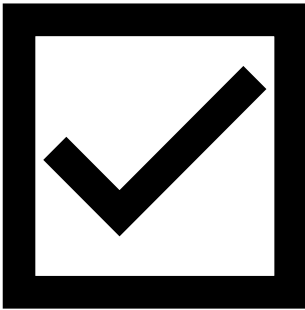
