Federal Subsistence Regional Advisory Councils to hold public meetings

The Federal Subsistence Regional Advisory Councils will hold public meetings between September 16 and October 30, 2025, to develop recommendations on proposals to change federal subsistence wildlife regulations for the 2026-2028 regulatory years and discuss other issues affecting subsistence in their regions.
