YUKON AREA END OF FALL SEASON SCHEDULE IN DISTRICTS 5 AND 6

TEMPORARY SPECIAL ACTION

Under Authority of: 36 CFR 242.10 and .19 43 CFR 51.10 and .19

Temporary Special Action No: 2-FC-15-25 Issued at: Fairbanks, Alaska, September 23, 2025

Current restrictions will be rescinded on the following effective dates:

Thursday, October 23, 2025, 12:00 p.m. for Subdistrict 5-ABC

Thursday, October 30, 2025, 12:00 p.m. for Subdistrict 5-D, Subdistrict 6-A, and the Upper Tanana

Current salmon closures and gillnet restrictions remain in place through December 31, but the 4-inch gillnet schedule is relaxed on the following effective date for listed river drainages:

Thursday, October 30, 2025, 12:00 p.m. for Porcupine, Teedriinjik, Kantishna, and Nenana river drainages

All restrictions in the Porcupine, Teedriinjik, Kantishna, and Nenana river drainages expire Wednesday, December 31, 2025, 11:59 p.m.

<u>EXPLANATION:</u> As fall chum and coho salmon runs are nearing completion, subsistence fishing restrictions are being removed in most areas based on fall chum salmon travel time. As the drainagewide and tributary escapement goals for fall chum salmon were not met, the Koyukuk, Teedriinjik, Porcupine, Kantishna, and Nenana River drainages will remain closed to subsistence salmon fishing through December to protect active spawning fall chum salmon. This Temporary Special Action announces the dates when all Federal action and subsistence restrictions are rescinded in the Yukon River District 5 and 6.

District 5 and Subdistrict 6-A:

Currently, subsistence salmon fishing remains closed for Chinook and chum salmon. Fishing for coho salmon and nonsalmon with selective gear remains open 24 hours per day, 7 days per week. Fishing with 4-inch or smaller mesh gillnets and manned fishwheels for coho salmon and nonsalmon is allowed from noon Thursdays to noon Sundays. Fishing for whitefish and other nonsalmon with 6-inch gillnets is open 24 hours per day, 7 days per week in designated, nonsalmon areas off the mainstem river only. Gillnets in all areas are restricted to 60-feet or less in length and must be operated as a set net near shore.

Upper Tanana (including waters in Tetlin National Wildlife Refuge and Wrangell-St. Elias National Park and Preserve):

Currently, subsistence salmon fishing remains closed for Chinook and chum salmon. Fishing for coho salmon and nonsalmon with selective gear and 4-inch or smaller mesh gillnets remains open 24 hours per day, 7 days per week. Gillnets are restricted to 60-feet or less in length and must be operated as a set net near shore.

REGULATION:

On the effective dates below, 36 CFR 242.27(e)(3) and 43 CFR 51.27(e)(3) Subsistence taking of fish—Yukon-Northern Area are further amended to read:

§___.27(e)(3)(ii) – In Federal public waters of the Yukon River District 5 and 6, excluding the Porcupine, Teedriinjik, Kantishna, and Nenana drainages, all Federal action and subsistence restrictions (described above) are rescinded on the following dates:

Subdistrict 5-ABC:

Effective Thursday, October 23, 12:00 p.m., all Federal action and subsistence restrictions are rescinded. Subsistence fishing opens 24 hours per day, 7 days per week with 7.5-inch and smaller mesh gillnets and all other legal gear.

Subdistrict 5-D, Subdistrict 6-A, and the Upper Tanana:

Effective Thursday, October 30, 12:00 p.m., all Federal action and subsistence restrictions are rescinded. Subsistence fishing opens 24 hours per day, 7 days per week with 7.5-inch and smaller mesh gillnets and all other legal gear.

Porcupine, Teedriinjik, Kantishna, and Nenana river drainage closed areas:

§____.27(e)(3)(ii) — In Federal public waters of the Porcupine, Teedriinjik, Kantishna, and Nenana river drainages, excluding Lake Minchumina, fishing with 4-inch or smaller mesh gillnets for coho salmon and nonsalmon will be allowed 24 hours per day, 7 days per week on October 30 and restrictions are in effect until December 31:

Effective Thursday, October 30, 2025, 12:00 p.m., fishing for coho salmon and non-salmon with gillnets of 4-inch and smaller mesh is allowed 24 hours per day, 7 days per week. Chinook and chum salmon harvest remains closed.

Effective Wednesday, December 31, 2025, 11:59 p.m., all Federal action and subsistence restrictions are lifted. Subsistence fishing opens 24 hours per day, 7 days per week with 7.5-inch and smaller mesh gillnets and all other legal gear.

Coho salmon fishing remains limited to federally qualified subsistence users until these actions are rescinded. Salmon are not expected to be caught in significant numbers after restrictions are lifted. Please exercise caution when fishing near freeze-up as conditions could be unsafe. Gillnets of 6-inch and smaller mesh remain open in designated nonsalmon harvest areas.

<u>JUSTIFICATION:</u> Escapement goals are not expected to be met for Chinook or chum salmon; therefore, restrictions are necessary for the rest of the salmon season. The coho salmon run size supports limited subsistence harvest. In the mainstem Yukon River, restrictions and salmon harvest closures are being rescinded in October. For the Porcupine, Teedriinjik, Kantishna, and Nenana river drainages, where active salmon spawning occurs until much later, salmon harvest closures are extended until December 31, however, the 4-inch gillnet schedule is being relaxed to 24 hours per day, 7 days per week. Pursuant to Title VIII of ANILCA, this Temporary Special Action (2-FC-15-25) rescinds subsistence fishing restrictions when migrating or spawning salmon are not expected to be caught in significant numbers.

This action was taken following coordination with the ADF&G fishery managers. The fishing schedules and removal of restrictions announced here match those issued concurrently by ADF&G in state waters (Fall Fishery Advisory Announcements #23). The Federal Subsistence Regional Advisory Council Chairs for the Yukon-Kuskokwim Delta, Eastern Interior, Western Interior, and Seward Peninsula Regional Advisory Councils were notified as was the Chair and vice-chair of the Yukon River Intertribal Fish Commission. Review was provided by the Office of Subsistence Management.
