# YUKON AREA SELECTIVE GEAR SUMMER CHUM SUBSISTENCE FISHING SCHEDULE FOR COASTAL DISTRICT, DISTRICTS 1–3, AND INNOKO RIVER DRAINAGE

Effective Date: Tuesday, June 30, 2026, 6:00 p.m. for Coastal District, District 1, District 2, District 3, and the Innoko River drainage

Expiration Date: Sunday, July 12, 2026, 11:59 p.m. for Coastal District and District 1;  
Wednesday, July 15, 2026, 11:59 p.m. for District 2;  
Friday, July 17, 2026, 11:59 p.m. for District 3 and the Innoko River drainage,  
unless superseded by subsequent special action

### EXPLANATION:

This Emergency Special Action opens the Federal public waters of the Coastal District, Districts 1–3, and the Innoko River drainage to subsistence harvest and retention of summer chum salmon with selective gear only. The action includes dip nets, manned fish wheels, beach seines, and hook and line. Fish-friendly fish wheel construction is required.

In Federal public waters, the summer chum salmon subsistence fishing opportunity is limited to federally qualified subsistence users for salmon in the Yukon River drainage.

Chinook salmon fishing remains closed (as announced in [TSA 03-KS-01-26](#) and [TSA 03-KS-02-26](#)). All gillnets were previously closed to protect the migrating Chinook salmon run (as announced in [ESA 03-KS-05-26](#) and [ESA 03-KS-07-26](#)). The gillnet closure is effective until the expiration date for each fishing district listed in the special actions.

The expiration dates for the summer chum salmon subsistence opportunity align with the planned harvest closures of fall chum and coho salmon at the start of the fall management season in each fishing district. This year, the fall management season starts on July 13 in the Coastal District and District 1 and will transition upriver based on the run timing of fall chum salmon.

Please practice respectful and safe fish handling techniques and ensure any Chinook salmon caught in selective gear types are released alive so they may continue upriver to their spawning grounds. If it appears that Chinook salmon are targeted while fishing for summer chum, fishing will be further restricted. While we acknowledge that allowing chum salmon gillnets to harvest chum salmon would be more efficient than selective gear, the Chinook run cannot support incidental harvest of Chinook salmon that would occur in chum-sized gillnets. While 4-inch and smaller mesh gillnets will be allowed again after the bulk of the Chinook salmon run, these gear may only be used to target non-salmon species.

## **REGULATION:**

Pursuant to the special actions in effect, Chinook and summer chum salmon fishing is currently closed to all users.

36 CFR 242.27(e)(3) and 43 CFR 51.27(e)(3) Subsistence taking of fish—Yukon-Northern Area is amended to read:

§ \_\_.27(e)(3)(ii) *In Federal public waters of the following Yukon River Drainage areas:*

**Coastal District and District 1, which includes the Black River and the communities of Chevak, Hooper Bay, Scammon Bay, Emmonak, Nunam Iqua, Alakanuk, and Kotlik:**

**Effective 6 p.m. Tuesday, June 30 until 11:59 p.m. Sunday, July 12, subsistence fishing with selective gear types (dip nets, beach seines, manned fish wheels, and hook and line gear) is open for summer chum salmon 24 hours per day, seven days per week. Chinook salmon must be released alive.**

**District 2, which includes Mountain Village, Pitka's Point, St. Mary's, Pilot Station, and Marshall:**

**Effective 6 p.m. Tuesday, June 30 until 11:59 p.m. Wednesday, July 15, subsistence fishing with selective gear types (dip nets, beach seines, manned fish wheels, and hook and line gear) is open for summer chum salmon 24 hours per day, seven days per week. Chinook salmon must be released alive.**

**District 3, which includes Russian Mission, and the Innoko River drainage:**

**Effective 6 p.m. Tuesday, June 30 until 11:59 p.m. Friday, July 17, subsistence fishing with selective gear types (dip nets, beach seines, manned fish wheels, and hook and line gear) is open for summer chum salmon 24 hours per day, seven days per week. Chinook salmon must be released alive.**

**While a fish wheel is operating, it must be manned at all times. Fish wheel basket sides and bottoms must be made of soft mesh material such as seine twine. Fish wheels must also have an adjustable or fixed slide or chute with a smooth bottom and closed cell foam lined sides that return Chinook salmon immediately back to the water.**

## **JUSTIFICATION:**

The summer chum salmon inseason projection indicates the drainage-wide escapement goal will be met. The lower end of the projection is well above the lower end of the drainage-wide goal of 500,000 summer chum salmon. The harvest from this limited selective gear opportunity is unlikely to adversely affect the drainage-wide escapement of the species.

Pursuant to the Alaska National Interest Lands Conservation Act, this Emergency Special Action **(03-KS-14-26)** allows retention of summer chum salmon in selective gear types in the Federal public waters of the Yukon River Coastal District, District 1, District 2, District 3, and the Innoko River drainage. This opportunity is limited to federally qualified subsistence users and will be implemented upriver based on migration timing and summer chum salmon presence in each area.

## **CONSULTATION AND OUTREACH:**

The Yukon River salmon outlooks and management strategies were discussed at a Federal public hearing; the Eastern Interior, Western Interior, and Yukon Kuskokwim Delta Regional Advisory Council meetings; the Yukon River Drainage Fisheries Association preseason meeting; at the Yukon River Panel and at the Yukon River Inter-Tribal Fish Commission annual meeting. manager offered formal Government-to-Government Tribal Consultation meetings with Yukon River drainage Tribal Governments upon request. The Federal fishery outlook and management strategy was sent to all Yukon Tribal and City governments on April 7. Approximately 3,500 copies of the Preseason Outlook flier were mailed to Yukon River fishing households in May.

This action was taken in coordination with the Alaska Department of Fish and Game (ADF&G) and USFWS fishery managers. The fishing schedules announced here match those issued concurrently by the ADF&G in State waters (**Summer Fishery Advisory Announcement #20**). The Federal Subsistence Regional Advisory Council Chairs for the Yukon-Kuskokwim Delta, Eastern Interior, Western Interior, and Seward Peninsula Regional Advisory Councils were notified as was the Chair and Executive Director of the Yukon River Inter-Tribal Fish Commission. Review was provided by the Office of Subsistence Management.

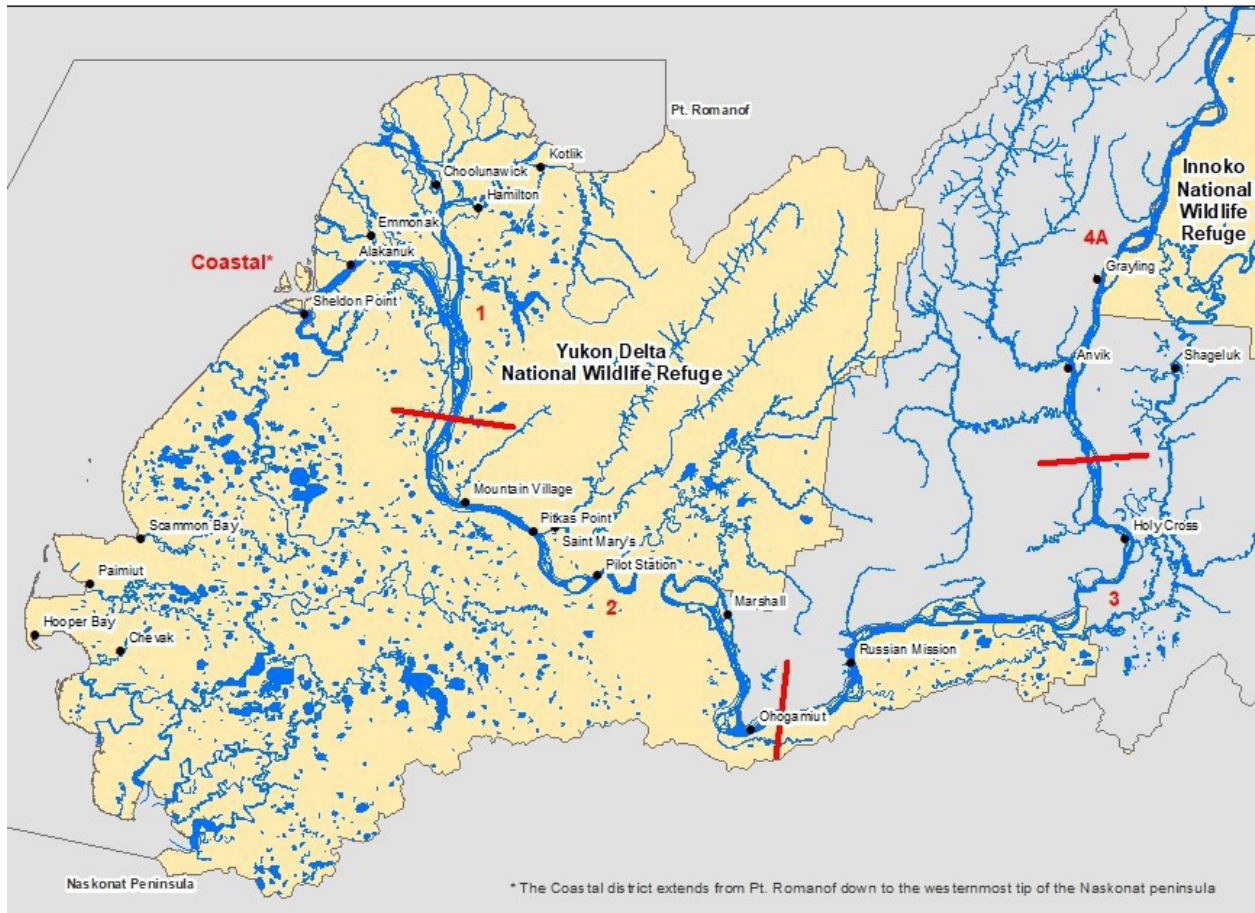
