STATEMENT OF PURPOSE

Request for Renewal Authorization for Use of Government Passenger Carriers (Fieldwork) for Home-To-Work Transportation Pursuant to 31 U.S. Code § 1344 for the Wildland Fire Management (WFM) programs in the Bureau of Indian Affairs (BIA), Bureau of Land Management (BLM), Fish and Wildland Service (FWS), and National Park Service (NPS).

RECOMMENDATION

Approve the request to authorize four essential positions for home-to-work use during extreme environmental conditions and fire danger to provide qualified fireline oversight for wildfires. For 2022 – 2024, 425 authorizations are being requested.



Authorization for Use of Government Passenger Carrier(s) for Home-to-Work for Fieldwork Pursuant 31 U.S.C 1344

Determination: The Secretary of the Interior is satisfied with the provided assurances that the duties for the position/series listed below perform work for the Department of the Interior as defined in FMR 41 CFR Subpart 102-5:

Purpose:

To provide immediate and timely response to wildfire incidents as they occur, and in limited conditions, to decrease the loss of life, property, and public and private lands.

Use of a Government vehicle by those occupying the described positions for home-to-work (HTW) transportation will substantially increase the efficiency and economy of the DOI under circumstances described, and such use is not for the purpose(s) of the personal comfort or convenience of the employee(s) involved. This determination and approval shall be updated as necessary and recertified every two years.


All users of Government vehicles must be vigilant in ensuring that Government vehicles are used only for official purposes. Employees are to be cautioned that every effort must be taken to avoid creating a perception that the use is not official. The following requirements also apply:

- All statutory, regulatory, and policy constraints on HTW must be communicated in writing to employees receiving this flexibility. This includes requirements detailed in Chapter 9 of the DOI Motor Vehicle Handbook.
- Before granting approval for HTW, supervisors will ensure that employees receiving this flexibility adequately understand all HTW statutory, regulatory and policy constraints, including the requirements detailed in Chapter 9 of the DOI Motor Vehicle Handbook. For example, employees will confirm knowledge of appropriate and inappropriate uses for HTW, including, but not limited to, who is allowed in the vehicles and who is not.

Understanding the rules for HTW benefits the government and provides protection for the employee.

- Bureau Directors are ultimately responsible for identifying and monitoring employees receiving this flexibility.
- Fleet Vehicles used for HTW must be designated as such in the Financial and Business Management System.
- Employees receiving this flexibility are responsible for maintaining logs and records verifying that HTW transportation was for official purposes. Logs will contain the name and title of the employee, the passenger carrier, dates of home-to-work transportation, location of residence, and duration. Further, employees are responsible for reporting HTW benefits to the IRS, in accordance with FMM 2020-08, "Home to Work Taxable Reporting of Fleet Use."

Department of the Interior Wildland Fire Management Program Home-to-Work Transportation Authorization 2022 Request Record

In accordance with the Department of the Interior Motor Vehicle Management Handbook (April 2019), the following information is included in the request for authorization to use a government passenger carrier for home-to-work-transportation:

(1) Job title and series number: The designated wildland fire program management positions include: Fire Management Officers (GS-0401), Assistant Fire Management Officers (GS-0401/0462), Fire Operations Coordinators (GS-0401), and Fire Operations Specialists (GS-401/0462).

(2) Duties of the position(s) which require the authorization: The positions designated may require the use of motor vehicles for the safe and efficient performance of field duties, which can include initial response to wildland fires for establishing command and control, and/or providing other leadership and oversight in an emerging incident.

The specific field duties of the Fire Management Officer (FMO), Assistant Fire Management Officer (AFMO), and Fire Operations Coordinator (FOC) positions include, but are not limited to:

- (a) coordinates and initiates on wildland fires all fire management activities based on firefighter and public safety, cost effectiveness, and values to be protected consistent with resource objectives, by using the full range of strategic and tactical options as described in an approved Fire Management Plan.

- (b) coordinates operations with cooperating agencies on multi-jurisdictional wildland fires addressing risk to human safety and potential for damages to resources and improvements.

- (c) manages the environmental and workplace hazards of the wildland fire environment and provides leadership and direction to subordinates in the recognition and mitigation of these hazards.

- (d) responsible for the on-the-job safety and health of all employees supervised.

- (e) may serve as initial response incident commander

The specific field duties of the Fire Operations Specialist (FOS) position include, but are not limited to:

- (a) assigns missions to ground and aviation wildland fire suppression resources. Makes efficient and effective use of multiple types of interagency wildland fire suppression resources with varying capabilities. Ensures common communications for interagency resources.

(b) provides protection for life, property and resources. Selects strategies and tactics to ensure safe operations for assigned resources. Recognizes potential hazardous situations and provides operational briefings. Initiates contacts with federal, state, and/or local law enforcement personnel as necessary to close roads, evacuate structures, and deal with the public.

(c) participates in development of incident objectives and strategies and tactics, to provide for safe operations and cost-effective incident management.

(3) The address of the permanent duty station: The information is provided in the table below.

(4) Type of passenger carrier: The information is provided in the table below.

(5) Justification – clearly citing the beneficial effects of work performance and expected results:

Use of Government passenger carriers for home-to-work transportation by those employee(s) occupying the described positions will substantially increase the efficiency and economy of the Department of the Interior under the circumstances described:

(a) extreme fire danger and/or high potential for above normal fire growth exists where an immediate response can directly reduce the damage to property and resources as well as limit the complexity of an emerging fire which results in lower threats to public and firefighter safety.

(b) response to wildland fire emergencies, or other circumstances, where there is an immediate, unforeseeable, temporary need to provide home-to-work transportation for the uninterrupted performance of the DOI's mission, such as during periods of extreme fire danger.

(c) establishing command and control and/or providing fireline leadership in an emerging incident that results in minimizing exposure to firefighters and the public. The need for competent, qualified oversight on all wildfires is a key factor in reducing wildfire risk to critical infrastructure, natural and cultural resources, and meeting DOI and Bureau mission goals.
