The position is located on a wildland fire module or crew within the fire management organization. The purpose of the position is to perform wildland fire suppression/management/control functions and serve as a firefighter on an engine, helitack, prescribed fire, wildland fire module, or on a hand crew. Primary duties are directly connected with the control and extinguishment of fires and/or maintaining and using firefighter apparatus and equipment. The duties of this position are so rigorous that employment is limited to young and physically vigorous individuals who must meet established age and physical qualification requirements.

## Forestry Aid Wildland Firefighter GS-0462-03

### **LEGACY SPD#: DOI103**

#### I. INTRODUCTION

This is a standard wildland fire management position description intended for use in the Department of Interior (DOI). The position is located on a wildland fire module or crew within the fire management organization. The purpose of the position is to perform wildland fire suppression/management/control functions and serve as a firefighter on an engine, helitack, prescribed fire, wildland fire module, or on a hand crew. This position is at the full performance level.

Other wildland fire related duties may involve fire prevention, patrol, detection, or prescribed burning. The incumbent will also be involved with the maintenance and repair of firefighting tools, equipment and facilities, and will receive firefighting training.

#### II. MAJOR DUTIES

#### **Primary Duties (80%)**

Serves as a member of a fire module/crew assigned to suppress the full range of wildland fires. Performs assignments as a wildland firefighter in developing a working knowledge of safety rules, basic fire behavior, fire suppression, and fuels management techniques, practices and terminology across several functions. The work may consist of fireline construction, the use of pumps and engines and hose lays using appropriate nozzles and adjustments resulting in the effective use of water and additives. Performs assignments on the fireline, searching out and extinguishing burning materials by moving dirt, brush and rock, using various hand tools such as shovels, Pulaskis, and McLeods, and applying water by hose or backpack pump, etc.

Chops brush and fells small trees in construction of fireline. Utilizes hand tools such as axes and Pulaskis, and may use power tools including chainsaws and portable pumps to control spreading of wildland fire and/or to prepare control lines prior to burning.

Patrols fireline on foot or vehicle to locate and extinguish embers, flare-ups, and hotspot fires that may threaten developed firelines.

Cleans, reconditions, and properly stores fire tools and equipment.

May work alongside trained fire personnel in more specialized assignments such as backfire and burnout, mobile and stationary engine attack, construction of helispots, helitack operations, and performing hover hookups.

Participates in fire and safety training in the techniques, practices, and methods of fire suppression and in the safe, efficient operation and use of tools, equipment and vehicles used in fireline activities. Participates in module/crew proficiency checks and drills. Participates in

safety sessions and fire critiques. Ensures own and welfare and safety of others in all aspects of the assignments.

The employee may be assigned fire and aviation duties working in and around aircraft such as helicopters. When this position is used in helitack operations the qualification requirements specified in the current Interagency Standards for Fire and Fire Aviation Operations (Redbook) must be met prior to entrance into this position.

When this position description is used in hotshot operations the qualification requirements specified in the current Standards for Interagency Hotshot Crew Operations must be met prior to entrance into this position.

#### Miscellaneous (20%)

May support the work of others doing project work involving fuel inventory, preparing associated reports, and hazard fuel reduction projects.

As a module or crew member, may perform project work such as road and trail maintenance, habitat manipulation, and miscellaneous equipment and facilities maintenance.

May assist higher level workers in forestry research efforts; in the marketing of forest resources; or in the scientific management, protection, and development of forest resources.

#### OTHER SIGNIFICANT FACTS

The duties of this position are so rigorous that employment is limited to young and physically vigorous individuals who must meet established age and physical qualification requirements.

This is a testing designated position (TDP) under the Department of the Interior Drug-Free Workplace Program.

Incumbent is subject to medical examination and must pass the work capacity test for arduous positions.

May require a valid state driver's license to operate light vehicles and 4X4s.

When this position description is used in helitack or hotshot operations see qualification requirements stated above.

Performs other similar duties as assigned.

#### III. FACTOR LEVELS

# **Factor 1 - Knowledge Required by the Position**

(Level 1-2, 200 points)

Working knowledge of standard wildland fire management program requirements, suppression tactics, methods and procedures and skill in the use of several wildland firefighting hand tools, pumps and hoses, and chainsaws sufficient to perform assigned basic standard fire suppression and prescribed fire assignments and to clean and maintain firefighting tools and equipment.

Working knowledge of fire behavior, hazards, and accepted fire safety practices and procedures to prevent injury and loss of life.

Ability to perform duties under stressful and adverse operating conditions, such as long work hours, heavy workloads, emergency situations, adverse working and environmental conditions.

Must possess the ability to verbally communicate sufficiently to work as a member of a team.

Knowledge of agency and interagency qualification, position task book requirements, and certification standards and procedures adopted by the National Wildfire Coordinating Group (NWCG).

Knowledge of reporting requirements and procedures.

Knowledge of appropriate act requirements to include the Equal Opportunity Act, Civil Rights Act, Age Discrimination in Employment Act, Rehabilitation Act, 29 CFR 1604.1l(a) Sexual Harassment sufficient to function within a diverse workforce.

### **Factor 2 - Supervisory Controls**

(Level 2-1, 25 points)

The supervisor or higher graded employee makes continuing, specific assignments detailing procedures to be followed. The supervisor or higher graded employee provides instruction for resolving problems involving unfamiliar or unusual situations. The work is closely controlled and the incumbent seldom works without a higher graded employee present. The supervisor insures that work in progress and finished work is completed according to instructions.

#### **Factor 3 - Guidelines**

(Level 3-1, 25 points)

Procedures for doing the work have been established and a number of specific guidelines exist such as standing oral instructions, and operating procedures, maps, equipment manuals, health and safety codes, fireline handbooks, field operations guides, and training prior to actual fuels management and fire suppression activities. The work requires little judgement to be made by the who employee works in strict adherence to the guidelines, Deviations or questions needing clarification are referred to the available supervisor or higher graded employee who is available while performing wildland fire suppression activities.

### **Factor 4 - Complexity**

(Level 4-2, 75 points)

Performs a variety of routine tasks in the suppression of wildland fires. May use a variety of hand and power tools and equipment.

As a wildland firefighter, uses basic knowledge to perform individually or as a member of a module/crew in a variety of assignments. The approach taken by the module/crew may vary dependent based upon the fire terrain, intensity of fire, fuels availability, wind velocity, and resource values. Specific tasks, use of tools and methods, and the sequence in which tasks are to be done are determined by evaluation of the situation and issues involved. Consideration must also be given to slope, weather conditions, fuels and other fire behavior factors while performing wildland fire suppression.

#### **Factor 5 - Scope and Effect**

(Level 5-2, 75 points)

The work involves the execution of specific rules, regulations, or procedures and typically comprises a complete segment of an assignment or project of broader scope. Work involves the execution of specific procedures, techniques, which differ with each fire's fuel type, weather conditions, and topography. The effect of the work performed is to minimize loss of natural resources, improvements, property or life. The performance of the employee as a member of a module/crew contributes to the overall effectiveness of the wildland fire management effort.

## **Factors 6 & 7 - Personal Contacts & Purpose of Contacts**

(Level 1a, 30 points)

Contacts are primarily with other members of the module/crew, the module/crew leader/supervisor, and others in the wildland fire management organization and may include parties outside, such as public land users. Contacts with coworkers are made to exchange information about the immediate work assignments, procedures operational problems and any additional instruction on how the work is to be done.

Meets and deals on day-to-day matters with co-workers. Contacts with public land users involve the exchange of information.

### **Factor 8 - Physical Demands**

(Level 8-3, 50 points)

Essential functions require arduous exertion for protracted periods of time such as, but not limited to, extensive running, walking, climbing, kneeling, stooping, pulling hoses, jumping and twisting.

Duties involve rigorous fieldwork requiring above average physical performance, endurance and superior conditioning. Work requires prolonged standing, walking over uneven ground, and recurring bending, reaching, lifting and carrying of items weighing over 50 pounds and shared lifting and carrying of heavier items, and similar activities requiring at least average agility and dexterity.

Duties include the performance of physically demanding activities during emergencies, under adverse environmental conditions, and over extended periods of time. Operation of some specialized fire equipment can place extended physical stress on employee during fire activities.

## Factor 9 - Work Environment

(Level 9-3, 50 points)

The work is primarily performed in forest, range, and desert environments in steep terrain where surfaces may be extremely uneven, rocky, covered with thick tangled vegetation, smoky conditions, etc. Temperatures commonly exceed 100 degrees F and fall below freezing. Risks include smoke inhalation, fire entrapment, snake or insect bites and stings, exposure to excessive machinery noise, and falling and rolling material. Employee must adjust and cope with exposure to weather elements, dust and smoke, poor bivouac and eating situations under an unpredictable set of circumstances. Employee may be required to live in backcountry camps for extended periods of time. The hazardous nature of the work requires that personal protective equipment be worn (boots, hard hat, gloves, flame resistant clothing, etc.). Work may require travel by fixed-wing or rotor-wing aircraft.
