

## Why We Conduct the Decennial Census in the Island Areas



The United States Constitution mandates that a census of the nation's population be taken every 10 years. Title 13 of the U.S. Code authorizes the Secretary of Commerce (delegated to the Director of the U.S. Census Bureau) to undertake the decennial census.

The geographic scope of the decennial census is specified in Title 13 U.S.C., Section 191 as covering the 50 states, the District of Columbia, Puerto Rico, the *Commonwealth of the Northern Mariana Islands, Guam, the U.S. Virgin Islands, and "as may be determined by the Secretary, such other possessions and areas over which the United States exercises jurisdiction, control, or sovereignty." The latter authority of the Secretary includes American Samoa.* 



#### Overview of the Island Areas Censuses

- Census Bureau partnered with Island Areas local governments to conduct the 2020 Censuses of American Samoa, the Commonwealth of the Northern Mariana Islands, Guam, and the U.S. Virgin Islands.
- This partnership was established through a contract between the Census Bureau and the Governor of each Island Area.
- The Census Bureau provided funds, methodology, data collection instruments/materials, IT infrastructure, and on-site Census Advisors for oversight.

- Island Areas governments were responsible for conducting the data collection activities, including hiring office and field staff.
- Each Island Area governor named a local government organization to carry out the data collection activities.
- Five Island Area Census Offices were established: three in the Pacific Island Areas, and two in the U.S. Virgin Islands.
- Contracts were signed in December 2018 and closed out on January 31, 2021.

### **Data Collection Methodology**

- The 2020 Island Areas Censuses were initially designed with a paper-based, in-person enumeration methodology to collect highquality data. Data collection operations included Address Listing, Enumeration, and Quality Control.
- During Address Listing, trained field staff identified and listed every place where people could live or stay.
- During Enumeration, trained field staff conducted in-person interviews with respondents using a paper questionnaire.
- Quality control measures were incorporated throughout each phase of the operation.

- In March 2020, due to the COVID-19
   pandemic, all Island Areas paused operations
   due to Island Area government stay at home
   orders and/or social distancing guidance.
- The primary method of enumeration continued to be in-person interviews using a paper questionnaire once operations resumed in June 2020.
- A supplemental in-bound telephone data collection option was offered to respondents to mitigate COVID-19 concerns.
