OST Options

Termination of Office

(1) Conditioned upon implementation of reforms

The Special Trustee, in processing a termination date under section 4043 (a) (2) (C) of this title, shall ensure continuation of the Office until all reforms identified in the strategic plan have been implemented to the satisfaction of the Special Trustee.

OST Options

• (2) 30-Day notice


Thirty days prior to the termination date proposed in the plan submitted under this section, the Special Trustee shall notify the Secretary and the Congress in writing of the progress in implementing the reforms identified in the plan. The Special Trustee, at that time, may recommend the continuation, or the permanent establishment, of the Office if the Special Trustee concludes that continuation or permanent establishment is necessary for the efficient discharge of the Secretary's trust responsibilities.

OST Options

• (3) Termination date

The Office shall terminate 180 legislative days after the date on which the notice to the Congress under paragraph (2) is provided, unless the Congress extends the authorities of the Special Trustee. For the purposes of this section, a legislative day is a day on which either House of the Congress is in session.


Trust Services

Workload

- Processes and reconciles more than 34,000 transactions daily
- Manages approximately \$1 billion in receipts annually
- Disburses approximately \$869 million annually:
 - ≈\$583 million disbursed electronically (67%)
 - ≈\$286 million disbursed by paper check (33%)
 - Processes more than 755,000 disbursements annually:
 - ≈194,000 issued electronically (26%)
 - ≈561,000 issued by paper check (74%)
- Prepares more than 64,000 tax forms annually
- Provides approximately 758,000 Statements of Performance to tribal and individual beneficiaries annually
- Processes approximately 8,600 probate packages annually


- Office of Trust Reporting and Reconciliation is responsible for:
 - Reconciling subsidiary and controlled accounts
 - Monitoring trust funds activities at the OTFM and field levels
 - Preparing internal and external financial accounting reports
 - Preparing accurate and timely managerial reports and required tax forms
 - Reconciling trust funds activities including custodial management of financial assets and compliance and interface with Treasury cash flow reports
 - Reconciling cash daily
 - Complying with regulatory reporting requirements for OMB, Treasury, Interior
 - Providing reports to Treasury on check issuances



Office of Trust Funds Investments


- Office of Trust Funds Investments is responsible for:
 - Providing investment management for tribal trust funds ≈ \$3.2 billion and the IIM fund ≈ \$489 million, in accordance with applicable laws, regulations and policies
 - Planning, developing, operating and controlling the buying, selling and trading of investment instruments
 - Providing technical advice and assistance on investment-related matters to Indian tribes, Fiduciary Trust Officers and OST senior management

 Office of Budget, Finance and Administration (BF&A) is responsible for all aspects of the OST budget, strategic planning, Activity-Based Costing Management (ABC/M), and Government Performance and Results Act (GPRA) measurement. BF&A coordinates finance, procurement, and personnel activities. The Office performs all administrative functions within OST, including property; space; facilities support, and mailing trust fund Disbursements, Statements of Performance and **Explanations of Payment.**

- The Information Technology Program Manager (ITPM) is responsible for:
 - Providing Information Technology (IT) and IT security for OST and OHTA nationwide
 - Overseeing and directing IT support services including technical support

 - Managing electronic and hard copy records activities
 - Ensuring interfaces with other systems and developing a strategic plan to support business processes in support of the DOI Strategic Plan

- Office of Trust Records (OTR) reports to the IT Program Manager and is responsible for:
- Managing the Bureau of Indian Affairs (BIA), Bureau of Indian Education (BIE), Assistant Secretary for Indian Affairs (ASIA), and OST records programs consistent with requirements set forth in 44 U.S.C. Chapter 31
- Developing and managing the fiduciary trust records program in concert with other offices in OST, BIA, Office of Natural Resources Revenue (ONRR), Bureau of Land Management (BLM), and the Office of Hearings and Appeals (OHA)

OTR continued

- Coordinating activities with offices and agencies such as the Office of the Solicitor, the National Archives and Records Administration (NARA), the Department of Justice, and the Office of Management and Budget
- Serving as the Department's designated official (OTR Director) responsible for authorizing access to Indian trust records at the American Indian Records Repository (AIRR)
- Establishment of the American Indian Records Repository
 - Collected and indexed 223,867 boxes of Indian Affairs Records
 - Summary of box contents kept in a searchable database

- Office of Trust Review & Audit (OTRA) is responsible for identifying weaknesses in fiduciary trust operations, rating performance, reporting findings and making corrective action recommendations by:

Office of Trust Review & Audit

- Cumulative Indian Trust Examinations as of 12/31/2011:
 - Performed 342 Indian Trust Examinations (ITE) and issued 316 ITE Reports
 - Identified 944 issues in the ITEs
 - Resolved 476 findings via response or follow-up (50%)
- Total Number of Indian Trust Examinations in FY 2012:
 - Performed 8 Indian Trust Examinations (ITE) and issued 6 final ITE reports
 - Identified 5 findings in the ITEs

- Deputy Special Trustee -Trust Accountability
 - is responsible for managing and supervising the Office of Trust Training and the Trust Program Management Center.

Trust Accountability

• Office of Trust Training is responsible for:

- Developing and coordinating training of employees in support of fiduciary trust activities
- Ensuring proper accreditation of staff in professional series and/or accreditation required for the performance of specific duties and responsibilities
- Maintaining an active partnership with the National Indian Programs Training Center and other government bureaus and offices

- Office of External Affairs is responsible for:
 - Developing messages for public outreach
 - Managing internal and external communications
 - Supporting Indian Self-Governance and Self-Determination
 - Serving as congressional liaison for Indian trust management issues

Office of External Affairs (OEA)

- OEA supports the Department's goal of Serving Communities – Fulfill Indian Fiduciary Trust Responsibilities by:
 - Supporting tribal participation in operating OST programs through self-determination contracts and 29 selfgovernance compacts
 - Providing tribes with technical assistance to withdraw tribal funds from trust status for tribal management
 - Communicating advancements in trust management with:
 - Tribal and individual Indian beneficiaries
 - Congress
 - Inter-departmental partners
 - Local and national media

- Office of Historical Trust Accounting was transferred to OST in 2007 and is responsible for:
 - Tribal litigation & settlement negotiations working with DOJ & SOL
 - Providing data, analysis & other support necessary to implement the Claims Resolution Act of 2010, which authorized settlement of the Cobell v Salazar class action litigation
 - Special Deposit Accounts & Youpee Escheat Accounts research and distribution

- Office of Appraisal Services was transferred to OST in 2003 and was managed by the National Business Center (NBC) from 2004-2008. OAS provides:
 - Impartial opinions of value for a variety of specific real property interests on land owned in trust or restricted fee status
 - Appraisal services through Regional Supervisory Appraisers, and regional appraisal staff

Deputy Special Trustee - Field Operations

is responsible for leading and overseeing interfaces with trust beneficiaries through supervision and management of Trust Administrators and the Trust Beneficiary Call Center.



Trust Beneficiary Call Center Began on December 3, 2004

- The Call Center is a nationwide network which allows beneficiaries to access information concerning their trust assets
- The Call Center is also a tool to document requests from beneficiaries (individuals and Tribes) and track resolution of those requests
- Over 911,903 calls have been logged since Dec 3, 2004
- 94% of all calls were handled and resolved at the Call Center
- 6 % referred to OST FTOs for further resolution


