

Self Determination


- Tribal Government:



Revenue By Region




Administrative Assessment and Streamlining

- Administrative Assessment
 - Realign administrative functions such as budget, accounting, contracting, etc. from central to the regions
 - Managing Administration Functions at a Local Level
 - Enhance accountability, responsiveness, efficiency and customer service
 - Duty stations for field staff do not change, just reporting structure
- Streamlining
 - BIA, BIE, and ASIA allows Regions and Tribes to Identify Options to improve efficiencies
 - Effectiveness Government operated Programs
 - Protection of tribal programs and services

Funding History


Annual Appropriations


Annual Appropriations

Continuing Resolution

- Background
- Under the U.S. Constitution and federal law, no funds may be drawn from the U.S. Treasury or obligated by federal officials unless appropriated by law.
- History and Recent Trends

Continuing resolutions date from at least the late 1870s, and have been a regular part of the annual appropriations process for over 50 years.

- Types of Continuing Resolutions
 - Interim (or partial) continuing resolutions
 - Full-year continuing resolutions
- Substantive Legislative Provisions
 - Included comprehensive measures that establish major new policies and amend permanent provisions of law
- Funding Gaps
 - Only excepted activities include
 - Those involving the orderly termination of agency functions:
 - Emergencies involving the safety of human life or the protection of property;
 - Activities authorized by law.

Budget Control Act: A Breakdown

- Establishes the Joint Select Committee on Deficit Reduction to identify \$1.5 trillion in deficit reduction over the period of fiscal years (FYs) 2012-2021.
- Sequestration process across-the-board spending cuts applied to programs in order to meet a budgetary goal (\$1.2 trillion).
- Cuts will be applied uniformly to all programs, projects, and activities within a budget account.
- Programs may be defined through the Committee Support Table.
- We are entering a period where Federal and Tribal programs and policies will be challenged.

THE SEQUESTER WOULD IMPACT

- Native American programs -
- Tribes would lose almost \$130 million in funding from the Department of the Interior.
- Reductions would be necessary in many areas including:
 - Human services
 - Law enforcement
 - Schools
 - Economic Development
 - Natural Resources
 - Leasing Tribal Lands
 - New Development
