Subject: Designation/Reaffirmation of Louisiana's Trustee Council and Executive Committee Representatives



To implement and effectuate the Natural Resource Damage Assessment, Early Restoration and broader Restoration planning processes, negotiations, and other matters that may arise with respect to the Deepwater Horizon Oil Spill, the Designated Natural Resource Trustee Officials for the State of Louisiana make the following designations pursuant to Sections VI and VII of the Memorandum of Understanding Relating to the Natural Resource Damage Assessment and Restoration Resulting from the Deepwater Horizon Mobile Offshore Drilling Unit and the Subsea Macondo Well (the "MOU") among the State and Federal Natural Resource Trustees for the Deepwater Horizon Oil Spill:


