Departments of Energy and Interior Award Nearly \$17 Million for Advanced Hydropower Technologies

WASHINGTON, D.C.—U.S. Department Energy Secretary Steven Chu and U.S. Department of the Interior Secretary Ken Salazar today announced nearly \$17 million in funding over the next three years for research and development projects to advance hydropower technology. Sixteen projects in 11 states were selected through a competitive grant process for their ability to contribute to the development of innovative technologies that produce hydropower more efficiently, reduce costs and increase sustainable hydropower generation. The funding will help advance the Obama Administration's goal of meeting 80 percent of our electricity needs from clean energy sources by 2035.

"By improving and deploying advanced hydropower technologies, we can maximize our use of this proven clean energy resource, create jobs, and reduce our reliance on fossil fuels," said Secretary Chu. "Hydropower can be used to store energy to help utilities better integrate other sources of renewable energy like wind and solar into the grid, improving our energy security and diversifying our clean energy resources."

"This Administration is supporting innovative development of hydropower – one of our largest renewable energy sources – with an emphasis on reducing or eliminating environmental impacts on ecosystems," Secretary Salazar said. "These research and development dollars will help make hydropower technology more efficient and cost-effective as we continue to promote clean energy resources and build an American renewable energy economy in an environmentally responsible manner."

These projects will advance sustainable renewable energy generation from small (less than 30 megawatts) hydropower resources, enhance environmental performance of hydropower, test innovative, cost-effective technologies for hydropower development at low-head (less than a 30 foot drop) sites such as irrigation canals and non-powered dams, and spur deployment of pumped storage hydropower. By allowing utility operators to pump water up to a dam or impoundment during periods of low electricity demand and release water during times of peak electricity demand, pumped storage hydropower improves the reliability of electric grids and helps increase the use of variable renewable energy resources such as wind and solar power.

Hydropower is a source of renewable energy that can be relied upon for long-term, stable production of domestic electricity. The hydropower industry currently employs more than 300,000 workers in the United States, making it not only the oldest, but also the largest renewable power generation workforce in the nation.

The selections announced today focus on four approaches to advancing hydropower in the United States:

- Sustainable Small Hydropower: Nine projects awarded by DOE will receive a total of \$5.8 million and one project jointly funded by DOE and DOI will receive \$1.5 million to research, develop, and test low-head, small hydropower technologies that can be quickly and efficiently deployed at existing non-powered dams or constructed waterways. These projects will focus on system or component model development, as well as the real-world testing of these systems.
- Sustainable Pumped Storage Hydropower: Two projects awarded by DOE will receive a

- total of \$6.8 million to spur deployment of advanced pumped storage hydropower in the United States. One award will conduct pre-construction, geotechnical evaluations for a pumped storage hydropower project in the early stages of development that will use advanced technology to dynamically respond to the electrical grid, enabling the integration of wind and solar energy. DOE is also supporting analyses that calculate the economic value of pumped storage hydropower.
- Environmental Mitigation Technologies for Conventional Hydropower: Three projects awarded by DOE will receive a total of \$2 million to develop innovative hydropower technologies that will enhance environmental performance while increasing electricity generation, mitigating fish and habitat impacts and enhancing downstream water quality.
- Advanced Hydropower System Testing at a Bureau of Reclamation Facility: One project jointly funded by DOE and DOI will receive \$746,000 to support system tests of innovative, low-head, small hydropower technologies at a non-powered site owned by the U.S. Department of the Interior's Bureau of Reclamation. DOE's funding is targeted at research and development, whereas the Bureau of Reclamation's funding is targeted at implementation. Energy cost reductions demonstrated at this site could be replicated at other Bureau of Reclamation sites.

Projects Will Be Part of 50-State Report

WASHINGTON — Just days before the release of a 50-state report outlining some of the country's most promising ways to reconnect Americans to the natural world, Secretary of the Interior Ken Salazar today highlighted two projects in the state of New Jersey that will be included in the final report — representing what states believe are among the best investments in the nation to support a healthy, active population, conserve wildlife and working lands, and create travel, tourism and outdoor-recreation jobs across the country.

Landscape conservation and provision of water access and other recreational opportunities at Barnegat Bay are among 100 projects nationwide that will be highlighted in next week's report two in every state — as part of President Obama's America's Great Outdoors initiative to establish a 21st century conservation and recreation agenda and reconnect Americans to the outdoors. The report is a result of 50 meetings with governors and stakeholders held by Salazar and other senior Interior officials to solicit ideas on how to best implement AGO in their states. These projects were identified for their potential to conserve important lands and build recreation opportunities and economic growth for the surrounding communities as part of close engagement with Gov. Chris Christie and the state of New Jersey, as well as private landowners, local- and tribal-elected officials, community organizations and outdoor-recreation and conservation stakeholders. The full 50-state report will be released in the coming weeks.

"Under the America's Great Outdoors Initiative, we are listening to the people of New Jersey and communities across America and working with them on locally-based projects that will conserve the beauty and health of our land and water and open up more opportunities for people to enjoy them," Salazar said. "My staff and I have been asking each governor for the most promising projects to support in their states, and we will do all we can to help move them forward." The two projects in New Jersey highlighted by Salazar in the forthcoming report are:

Barnegat Bay Water Access

Located along Barnegat Bay, Brick Township is a community of nearly 79,000 people. The state of New Jersey has designated it as an Urban Aid Community, indicating it is a low-income, highpopulation center in need of state funds for further support and development. Barnegat Bay is a vitally important natural, recreational, and economic resource for New Jersey and is a state priority.

The township is acquiring a 21-acre property for a park and recreation area that will provide muchneeded public waterfront access and outdoor-recreation opportunities on the bay, as well as a link to the Edwin B. Forsythe National Wildlife Refuge.

The township has proposed improvements that include a boardwalk promenade along the bay; a kayak/canoe launch; a playground; a water-play area; and landscaping. These enhancements should be done with an environmentally friendly design to reduce storm water entering the bay and educate users about storm-water impacts on natural resources. This project supports AGO goals by increasing recreational access and providing close-to-home open spaces for underserved communities.

Barnegat Bay Landscape Preservation and Recreation

Landscape preservation in the Barnegat Bay watershed is part of a comprehensive effort to restore the coast of the nation's most densely populated state, New Jersey.

As a point of access to nature for so many residents, Barnegat Bay also is of significant recreational value. A longtime center for commercial fishing, the bay is also popular with recreational boaters and holds great potential for further ecotourism. It is also in close proximity to a number of state parks containing valuable ecosystems and wildlife habitat. Increased public access along New Jersey's waterways is, therefore, a significant state interest because it will allow residents increased environmental and recreational opportunities.

In order to achieve this, the state has placed a priority on acquiring 18 parcels totaling 1,019 acres as valuable additions to Double Trouble and Bass River state parks, as well as to Colliers Mills and Turkey Swamp wildlife management areas. These lands will provide increased public access to recreation opportunities along New Jersey's waterways and wildlife-management areas. These efforts will also improve the bay's health, further complementing AGO goals.

The report will also include potential actions by Interior and its bureaus to support the projects identified. In New Jersey, for example, the Department could provide financial assistance for critical land acquisition near Double Trouble and Bass River state parks and Colliers Mills and Turkey Swamp wildlife management areas.

The Department could also provide financial assistance for creating new and enhancing existing outdoor recreation areas and linking the Barnegat Bay Township to Forsythe National Wildlife Refuge.

The Department of the Interior will work with each of its key bureaus — including the National Park Service, the Bureau of Land Management and the U.S. Fish and Wildlife Service — to direct available resources and personnel to make these projects a reality.

"The America's Great Outdoors Initiative turns the conventional wisdom about the federal government's role in conservation on its head," Salazar said. "Rather than dictate policies or conservation strategies from Washington, it supports grassroots, locally driven initiatives."

AMERICA'S GREAT OUTDOORS: Salazar Highlights Two Proposed Projects in New Jersey to Promote Outdoor Recreation, Conservation

Projects Will Be Part of 50-State Report

WASHINGTON — Just days before the release of a 50-state report outlining some of the country's most promising ways to reconnect Americans to the natural world, Secretary of the Interior Ken Salazar today highlighted two projects in the state of New Jersey that will be included in the final report — representing what states believe are among the best investments in the nation to support a healthy, active population, conserve wildlife and working lands, and create travel, tourism and outdoor-recreation jobs across the country.

Landscape conservation and provision of water access and other recreational opportunities at Barnegat Bay are among 100 projects nationwide that will be highlighted in next week's report two in every state — as part of President Obama's America's Great Outdoors initiative to establish a 21st century conservation and recreation agenda and reconnect Americans to the outdoors. The report is a result of 50 meetings with governors and stakeholders held by Salazar and other senior Interior officials to solicit ideas on how to best implement AGO in their states. These projects were identified for their potential to conserve important lands and build recreation opportunities and economic growth for the surrounding communities as part of close engagement with Gov. Chris Christie and the state of New Jersey, as well as private landowners, local- and tribal-elected officials, community organizations and outdoor-recreation and conservation stakeholders. The full 50-state report will be released in the coming weeks.

"Under the America's Great Outdoors Initiative, we are listening to the people of New Jersey and communities across America and working with them on locally-based projects that will conserve the beauty and health of our land and water and open up more opportunities for people to enjoy them," Salazar said. "My staff and I have been asking each governor for the most promising projects to support in their states, and we will do all we can to help move them forward." The two projects in New Jersey highlighted by Salazar in the forthcoming report are:

Barnegat Bay Water Access

Located along Barnegat Bay, Brick Township is a community of nearly 79,000 people. The state of New Jersey has designated it as an Urban Aid Community, indicating it is a low-income, highpopulation center in need of state funds for further support and development. Barnegat Bay is a vitally important natural, recreational, and economic resource for New Jersey and is a state priority.

The township is acquiring a 21-acre property for a park and recreation area that will provide muchneeded public waterfront access and outdoor-recreation opportunities on the bay, as well as a link to the Edwin B. Forsythe National Wildlife Refuge.

The township has proposed improvements that include a boardwalk promenade along the bay; a kayak/canoe launch; a playground; a water-play area; and landscaping. These enhancements should be done with an environmentally friendly design to reduce storm water entering the bay and educate users about storm-water impacts on natural resources. This project supports AGO goals by increasing recreational access and providing close-to-home open spaces for underserved communities.

Barnegat Bay Landscape Preservation and Recreation

Landscape preservation in the Barnegat Bay watershed is part of a comprehensive effort to restore the coast of the nation's most densely populated state, New Jersey.

As a point of access to nature for so many residents, Barnegat Bay also is of significant recreational value. A longtime center for commercial fishing, the bay is also popular with recreational boaters and holds great potential for further ecotourism. It is also in close proximity to a number of state parks containing valuable ecosystems and wildlife habitat. Increased public access along New Jersey's waterways is, therefore, a significant state interest because it will allow residents increased environmental and recreational opportunities.

In order to achieve this, the state has placed a priority on acquiring 18 parcels totaling 1,019 acres as valuable additions to Double Trouble and Bass River state parks, as well as to Colliers Mills and Turkey Swamp wildlife management areas. These lands will provide increased public access to recreation opportunities along New Jersey's waterways and wildlife-management areas. These efforts will also improve the bay's health, further complementing AGO goals.

The report will also include potential actions by Interior and its bureaus to support the projects identified. In New Jersey, for example, the Department could provide financial assistance for critical land acquisition near Double Trouble and Bass River state parks and Colliers Mills and Turkey Swamp wildlife management areas.

The Department could also provide financial assistance for creating new and enhancing existing outdoor recreation areas and linking the Barnegat Bay Township to Forsythe National Wildlife Refuge.

The Department of the Interior will work with each of its key bureaus — including the National Park Service, the Bureau of Land Management and the U.S. Fish and Wildlife Service — to direct available resources and personnel to make these projects a reality.

"The America's Great Outdoors Initiative turns the conventional wisdom about the federal government's role in conservation on its head," Salazar said. "Rather than dictate policies or conservation strategies from Washington, it supports grassroots, locally driven initiatives."

Dear Secretary Salazar:

The proposed Susquehanna-Roseland power line project will be an important new link in the nation's power grid. It will help provide reliable electric service for tens of millions of people in Pennsylvania, New Jersey and the broader region.

As you may know, the New Jersey Board of Public Utilities (BPU) approved the application of Public Service Electric and Gas Company (PSE&G) to construct the New Jersey portion of this 500-kilovolt power line in February 2010. The Pennsylvania Public Utilities Commission (PUC) approved the application of PPL Electric Utilities Corporation to construct the Pennsylvania portion of the line in January 2010. ¹

The BPU and the PUC considered a wide range of testimony and evidence on the same topics being considered in the National Park Service Environmental Impact Statement (EIS). Both Commissions were satisfied that the routes approved would have the least impact upon customers, communities, and the environment.

It is my understanding that National Park Service is considering a 90 day extension for completion of the EIS. This line is vitally important for regional electric service reliability. A delay would threaten service in the region, and service failures would have immeasurable economic impacts and, more importantly, would threaten the health and safety of our residents. I hope that you will review the timeline and process of the EIS and reduce the duration of the EIS to the previous schedule. In addition, the process should be transparent, and all alternate routes no longer under consideration should be made public. This would result in a Record of Decision by October 4, 2012, and allow

this critical element in the nation's electric infrastructure to be in service before the 2015 summer peak electricity use period.
