The Tribal Council members who will be here in Washington on those days will be T.J. Laffoon, Amelia Flores, and Dennis Walsh. They would be available to meet with the Deputy Secretary at any time on any of those three days. They would like to discuss emerging issues that the Tribe has dealing with the CAP as well as their ability to access and utilize their water allocation rights in the Colorado River. In addition, they would like to discuss concerns that exist with renewable energy projects in and around the reservation. Finally, they would like to discuss on-going challenges with regard to the treatment of leases and rights in their Western Boundary area of California.


