

1. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Registration for the Washington Monument Insta-Meet ("Insta-Meet") will be held online from 11:00 a.m. Eastern Time ("ET"), April 9, 2014, to 11:59 p.m. ET, April 16, 2014 ("Contest Period"). Insta-Meet is sponsored by the Department of the Interior (the "Sponsor") who is solely responsible for all aspects of this Insta-Meet.

2. ELIGIBILITY. The Insta-Meet is open to legal residents of the United States of America who are 18 years of age or older as of "Contest Start Date." Sponsor's employees and their immediate families are not eligible to participate or claim a prize. Only one entry form per person. Entries will only be accepted at www.doi.gov/InstaMeet. Void where prohibited or restricted by law. All federal, state and local laws, rules and regulations apply. By participating, entrants agree to abide by all terms of these Official Rules and to the decisions of the judge, and waive any right to claim ambiguity in the Insta-Meet or these Official Rules.

3. HOW TO REGISTER. 1.) As of 12:00 a.m. ET, [DATE] 2014, the entrant must:

c. Complete the specified registration form by April 9, 2014.

d. Be 18 years of age or older.

By registering, you represent that you have all necessary rights to grant a license to the Sponsor an irrevocable, royalty-free license to copy, distribute, modify, display, publish and re-use your entry submission and Instagram photos and videos for any purpose throughout the world and in any media and for any purpose and that you hereby grant such license together with the right to use your name and image. You agree that your participation is not for the purpose of endorsement of any commercial enterprise, organization, product or service. You certify that all information provided is true and correct. You further certify that all photos or videos will be created for the purpose of publicizing the re-opening of the Washington Monument and will be family-friendly, not include any violence, profanity, or direct attacks on individuals or organizations, and will not infringe on any third party rights.

5. SELECTIONS AND NOTIFICATION OF WINNERS. Winners will be determined on or after April 16, 2014, by evaluation of your answer to the question "Why would you like to be considered for the Washington Monument Insta-Meet") and to obtain the greatest State diversity. Applications that are not received through www.doi.gov/InstaMeet, exceed the space allotted or contain inaccurate or inappropriate messages **will not be judged**. Winners will be notified by email or Instagram® on or after April 16, 2014 and need not be present to win. Winners will be required to execute and return an Affidavit of Eligibility/Release of Liability/Publicity Release upon arrival, prior to participating in the Insta-Meet. Winners are solely responsible for all costs, including travel, that might be required to participate in this Insta-Meet. The winner will be disqualified if a selected winner fails to comply with these rules, cannot be contacted, is ineligible, fails to claim a prize, or fails to return the completed and executed Affidavit

and Releases in the stated time period as required, or if the prize notification or prize is returned as undeliverable. Acceptance of a prize constitutes permission to use the winners' names, likenesses, and statements for promotional and publicity purposes without additional compensation or limitation unless prohibited by law.
