8 quorum now, we're waiting for one more person but I  
9 think I'm going to call the meeting to order and it is  
10 according to my clock, it's 9:38.  
11  
12 And, roll call, Donald.  
13  
14 MR. MIKE: Yeah, thank you, Madame  
15 Chair. Roll call for the Bristol Bay teleconference  
16 meeting.  
17  
18 Mr. Pete Abraham.

22 MR. MIKE: Madame Chair, I informed Mr.  
23 Abraham of our upcoming teleconference meeting and I  
24 sent a message to his supervisor, I understand he's in  
25 a staff meeting.

29 MR. O'HARA: Here.

31 MR. MIKE: Ms. Nanci Morris.

33 MADAME CHAIR CHYTHLOOK: Okay, good  
34 morning. Review and adopt agenda and for the purpose  
35 of Richard, I'm going to go ahead and quickly read the  
36 agenda down.

4                   Then we have the closing comments and  
5                   then adjournment.  
6  
7                   MS. MORRIS LYON: I move to approve the  
8 agenda.  
9  
10                  MS. TOYUKAK: Second. Moses.  
11  
12                  MADAME CHAIR CHYTHLOOK: Okay, there's  
13 been a motion to approve the agenda. Motion by Nanci  
14 Morris, second by Moses Toyukak. All in favor, if  
15 there's no discussion, say aye.  
16  
17                  IN UNISON: Aye.  
18  
19                  MADAME CHAIR CHYTHLOOK: Okay, thank  
20 you. I guess we're -- we can maybe quickly welcome and  
21 introduction. The introductions, we have our Council  
22 members and we have other agency people on line, could  
23 you please introduce yourselves.  
24  
25                  MR. MIKE: We'll start with the Park  
26 Service.  
27  
28                  MADAME CHAIR CHYTHLOOK: Park Service.  
29  
30                  MS. GAMACHE: Good morning, Madame  
31 Chair. This is Jean Gamache with the National Park  
32 Service, Alaska Native Affairs tribal liaison.  
33  
34                  MS. MCBURNEY: Good morning, Madame  
35 Chair. This is Mary McBurney with the National Park  
36 Service and the Aniakchak National Monument SRC.  
37  
38                  MR. MIKE: RAC members.  
39  
40                  MADAME CHAIR CHYTHLOOK: Then the RAC  
41 members, quickly.  
42  
43                  MR. MIKE: We'll start with Naknek,  
44 King Salmon.  
45  
46                  MS. MORRIS LYON: Okay, this is Nanci  
47 Morris Lyon, King Salmon.  
48  
49                  MR. O'HARA: Dan O'Hara, Naknek.  
50

1 MR. MIKE: Dillingham, Manokotak.  
2  
3 MR. TOYUKAK: Moses Toyukak, Manokotak.  
4  
5 MR. DUNAWAY: Dan Dunaway, Dillingham.  
6  
7 MADAME CHAIR CHYTHLOOK: Molly  
8 Chythlook, Dillingham.  
9  
10 MR. WILSON: Richard Wilson, Naknek.  
11  
12 MR. MIKE: Chignik.  
13  
14 MR. JONES: John Jones, Chignik.  
15  
16 MR. BOSKOFISKY: Alvin Boskofsky,  
17 Chignik Lake.  
18  
19 MR. MIKE: And, Donald Mike, Regional  
20 Advisory Council coordinator from Anchorage office.  
21  
22  
23 MR. JOHNSON: And, also in Anchorage,  
24 Carl Johnson, Office of Subsistence Management.  
25  
26 MR. LIEBICH: And also in Anchorage,  
27 Trent Liebich, Office of Subsistence Management.  
28  
29 MR. MIKE: And we have Nathan as our  
30 court recorder.  
31  
32 MS. MORRIS LYON: Good morning, Nathan.  
33  
34 REPORTER: Good morning.  
35  
36 MR. O'HARA: Hi Nathan.  
37  
38 REPORTER: Hi Dan.  
39  
40 MR. O'HARA: Hey, John Jones.  
41  
42 MR. JONES: Hey.  
43  
44 MR. O'HARA: Dan O'Hara in Naknek, how  
45 are you doing?  
46  
47 MR. JONES: Good.  
48  
49 MR. O'HARA: We want to give you our  
50 winds.

1 (Laughter)  
2  
3 MR. JONES: I'm in Anchorage, you can  
4 let it blow into Chignik as far as you want.  
5  
6 MR. O'HARA: Oh, it's not much better  
7 than Anchorage, I'll tell you that.  
8  
9 MADAME CHAIR CHYTHLOOK: Okay, Donald.  
10  
11 MR. MIKE: Good morning. I want to  
12 thank all the Council members for taking the time to  
13 participate in this teleconference meeting of the  
14 Bristol Bay Regional Advisory Council. I sent out an  
15 email last week or a week and a half ago about the  
16 roster for the Aniakchak SRC to all the Council  
17 members, and also a memo from the National Park Service  
18 giving a summary of one of the candidates that the  
19 Council will be considering for an appointment to the  
20 SRC. So if you don't have any of that background  
21 information I think that the Park Service will give  
22 membership status of the Aniakchak and then summary of  
23 the candidate.  
24  
25 Thank you, Molly.  
26  
27 MADAME CHAIR CHYTHLOOK: Okay, we can  
28 move down to Aniakchak National Monument, SRC  
29 membership status.  
30  
31 MS. MCBURNEY: Thank you, Madame Chair.  
32 This is Mary McBurney for the record.  
33  
34 The Aniakchak SRC is comprised of nine  
35 members, three that are appointed by the Governor of  
36 Alaska, three by the Secretary of the Interior, and  
37 three by the Bristol Bay Regional Advisory Council.  
38 Currently there is one seat appointed by the Bristol  
39 Bay RAC that is vacant, Johnny Lind did not express  
40 interest in reappointed to the SRC leaving his seat  
41 open and his seat expired on November 4th of this year.  
42 There are also three other members that are expiring on  
43 -- that expired last month on the 4th of November,  
44 those are Robert Christensen and Ronald Lind, however,  
45 they're appointed by the Governor of Alaska and so  
46 those appointments are on a different track.  
47  
48 So today we're here to consider the  
49 nomination of Don Lind to fill the vacancy appointed by  
50 the Regional Advisory Council. There are three

1 requirements that a nominee needs to meet, or I should  
2 say two of three that a nominee needs to meet in order  
3 to be appointed by the RAC.

4  
5 A nominee needs to engage in  
6 subsistence uses within the Park or  
7 Monument.

8  
9 They need to be a member of the  
10 Regional Advisory Council;

11  
12 Or a member of the local Fish and Game  
13 Advisory Committee.

14  
15 Don Lind has been nominated to fill the  
16 vacant seat on the Aniakchak SRC. He meets the  
17 eligibility requirements for appointment by the RAC and  
18 he's also willing to serve as an SRC member.

19  
20 Mr. Lind is a longtime resident of  
21 Chignik Lake and the region and engages in subsistence  
22 uses in the Aniakchak National Monument. He has  
23 extensive knowledge of the region's fish and game  
24 resources and their utilization by local subsistence  
25 users. He is also a member in good standing of the  
26 Chignik Advisory Committee. He was nominated for a  
27 seat on the AC by the Chignik Lake Village Council, and  
28 was recently appointed by the State of Alaska to a two  
29 year term beginning on October 30th this year and  
30 expiring on October 31st of 2104.

31  
32 And, that completes my report on the  
33 membership status and the SRC candidate summary.

34  
35 Madame Chair.

36  
37 MADAME CHAIR CHYTHLOOK: Okay, thank  
38 you, Mary.

39  
40 Okay, any, I guess, discussions, or any  
41 questions from the Board members to Mary.

42  
43 MS. MORRIS LYON: My only comment would  
44 be that it sounds like that Mr. Lind is more than  
45 qualified for this position and I will be supporting  
46 him.

47  
48 MR. O'HARA: Madame Chair.

49  
50 MADAME CHAIR CHYTHLOOK: Yes.

1 MR. O'HARA: This is Dan. Mary  
2 McBurney it's nice to hear you, we missed you at our  
3 last meeting.  
4  
5 MS. MCBURNEY: I missed you too.  
6  
7 MR. O'HARA: Yeah. Now, there was  
8 three things, he had to be acquainted with subsistence  
9 use, a member of the Advisory, is that State of Alaska  
10 Advisory Committee?  
11  
12 MS. MCBURNEY: That's correct.  
13  
14 MR. O'HARA: Okay, and what was the  
15 third one?  
16  
17 MS. MCBURNEY: Be a member of the  
18 Regional Advisory Council.  
19  
20 MR. O'HARA: SRC.  
21  
22 MS. MCBURNEY: So he can either be a  
23 member of the RAC or a member of the local Fish and  
24 Game Advisory Committee.  
25  
26 MR. O'HARA: Yeah, so he's fully  
27 qualified. I agree with Nanci, I think we've got a  
28 real good candidate here. I know Donald, I know Donny  
29 pretty well.  
30  
31 MADAME CHAIR CHYTHLOOK: Okay, any  
32 further discussions, questions.  
33  
34 MR. WILSON: Madame Chair. Richard.  
35  
36 MADAME CHAIR CHYTHLOOK: Yes, Hi,  
37 Richard.  
38  
39 MR. WILSON: Yeah, hey, I've done a  
40 little bit of homework and I'm also in favor of the  
41 nominee that we have there. I'm actually walking  
42 through security as we speak so if I lose contact, I am  
43 in favor.  
44  
45 MADAME CHAIR CHYTHLOOK: Okay, thank  
46 you, Richard.  
47  
48 MR. O'HARA: Thanks, Richard, we  
49 probably need a motion to accept this -- this is Dan  
50 O'Hara, Madame Chair, I'll make a motion that we put



1 Donny Lind on the SRC out of Chignik Lakes.  
2  
3 MADAME CHAIR CHYTHLOOK: Okay,  
4 there's.....  
5  
6 MR. WILSON: I'll second that.  
7  
8 MR. BOSKOFISKY: Second.  
9  
10 MADAME CHAIR CHYTHLOOK: .....been a  
11 motion by Dan O'Hara and second by -- was that you,  
12 Alvin.  
13  
14 MR. BOSKOFISKY: Yes.  
15  
16 MR. WILSON: Yes, Richard.  
17  
18 MADAME CHAIR CHYTHLOOK: Richard, okay.  
19 Discussion.  
20  
21 MR. BOSKOFISKY: I beat you, Richard.  
22  
23 (Laughter)  
24  
25 MR. O'HARA: Question.  
26  
27 MADAME CHAIR CHYTHLOOK: There's been a  
28 question to accept Don Lind to the Aniakchak National  
29 Monument Subsistence Resource Commission. Any further  
30 comments, questions.  
31  
32 MR. O'HARA: For how long a term?  
33  
34 MADAME CHAIR CHYTHLOOK: My  
35 understanding is three.  
36  
37 MR. O'HARA: Okay, good, I'm ready to  
38 vote.  
39  
40 MADAME CHAIR CHYTHLOOK: Okay. All in  
41 favor of appointing from the Regional Advisory Council  
42 members Don Lind to the Aniakchak National Monument  
43 Subsistence Resource Commission say aye.  
44  
45 IN UNISON: Aye.  
46  
47 MADAME CHAIR CHYTHLOOK: Any  
48 objections.  
49  
50 (No objections.

1 MADAME CHAIR CHYTHLOOK: Hearing none,  
2 thank you. Don Lind now is appointed to the  
3 Subsistence Resource Commission. Thank you guys.  
4  
5 MR. MIKE: And I'll be drafting the  
6 appointment letter to Mr. Lind for your signature,  
7 Molly.  
8  
9 MADAME CHAIR CHYTHLOOK: Okay.  
10  
11 MR. BOSKOFISKY: And I would like to  
12 thank all you Council members for taking care of this  
13 using up your time and all the exciting things going  
14 on, thank you very much.  
15  
16 MS. MORRIS LYON: Thank you, Alvin.  
17  
18 MR. MIKE: Thank you, Alvin.  
19  
20 MR. O'HARA: Everybody have a great  
21 Christmas.  
22  
23 MADAME CHAIR CHYTHLOOK: Okay. Donald  
24 just make a comment and he's going to be drafting a  
25 letter of acceptance for my signature after the meeting  
26 here.  
27  
28 MS. MORRIS LYON: Great, thank you very  
29 much Donald.  
30  
31 MR. MIKE: Thank you all Council  
32 members for participating.  
33  
34 MADAME CHAIR CHYTHLOOK: Yeah, thank  
35 you. Thank you, Moses, for coming on last minute, I  
36 know it's cold, everybody's trying to stay warm so I  
37 really -- we really appreciate your participation.  
38  
39 MR. DUNAWAY: I really want to thank  
40 Mr. Lind for accepting the position so that they can  
41 move forward with their work.  
42  
43 MADAME CHAIR CHYTHLOOK: Okay.  
44  
45 MR. BOSKOFISKY: Mary McBurney, are you  
46 still there?  
47  
48 MS. MCBURNEY: Yes, I am.  
49  
50 MR. BOSKOFISKY: Whenever you get a

1 chance, could you give me a call?  
2  
3 MS. MCBURNEY: I can give you a call  
4 early this afternoon, would that work?  
5  
6 MR. BOSKOFISKY: Sure.  
7  
8 MS. MCBURNEY: Okay, great.  
9  
10 MR. BOSKOFISKY: Like maybe around 1:00.  
11  
12 MS. MCBURNEY: Yeah, about 1:00  
13 o'clock.  
14  
15 MR. BOSKOFISKY: Okay, that'd be great.  
16  
17 MS. MCBURNEY: Okay, talk to you then.  
18  
19 MR. BOSKOFISKY: Okay, thanks a lot.  
20  
21 MS. MCBURNEY: You bet.  
22  
23 MADAME CHAIR CHYTHLOOK: Okay, thanks  
24 Alvin. Anyone with any closing comments.  
25  
26 MS. MORRIS LYON: Merry Christmas  
27 everyone.  
28  
29 MR. BOSKOFISKY: Thank you all Bristol  
30 Bay RAC members for taking care of this issue, we'll be  
31 looking forward to the next meeting. Thank you very  
32 much.  
33  
34 MADAME CHAIR CHYTHLOOK: And thank you  
35 Alvin for all your work, your leadership regarding this  
36 Commission.  
37  
38 Was that you, Nanci?  
39  
40 MS. MORRIS LYON: Yep, I said Merry  
41 Christmas everyone.  
42  
43 MADAME CHAIR CHYTHLOOK: Okay, Merry  
44 Christmas to you.  
45  
46 MR. WILSON: This is Richard, we'll be  
47 seeing you.  
48  
49 MADAME CHAIR CHYTHLOOK: Okay, have a  
50 safe trip Richard.

1 MR. WILSON: All right.  
2  
3 MADAME CHAIR CHYTHLOOK: Okay, I need a  
4 motion to adjourn.  
5  
6 MR. TOYUKAK: So moved Madame Chair.  
7  
8 MADAME CHAIR CHYTHLOOK: Who's that,
