SUBSISTENCE FISHING CLOSURE IN WOMANS (WOMENS) BAY TO CONSERVE BUSKIN RIVER ORIGIN SOCKEYE SALMON

EMERGENCY SPECIAL ACTION

Under Authority of: 36 CFR 242.10 and .19
50 CFR 100.10 and .19

Emergency Special Action No: 9-RS-01-23

Issued at: Kodiak, Alaska, June 15, 2023

Effective Date: 12:01 a.m. Saturday, June 17

Expiration Date 12:01 a.m. Saturday, July 15 unless superseded by subsequent special action.

EXPLANATION: This Emergency Special Action closes the take of Sockeye Salmon in the Federal public waters of Womans (Womens) Bay near the city of Kodiak, which includes all Federal public waters of Chiniak Bay west of a line from Cliff Point (57° 43.51' N. latitude, 152° 26.60' W. longitude) to a point near Gibson Cove (57° 46.62' N. latitude, 152° 26.80' W. longitude).

The Kodiak Area Federal Subsistence In-season Manager, under the authority delegated by the Federal Subsistence Board, has been collaborating with Regional Advisory Council representatives and the Alaska Department of Fish and Game (ADF&G) Commercial Fisheries Manager about the extremely low number of Sockeye Salmon returning to Buskin River. Only 276 Sockeye Salmon have passed the weir as of June 13th. It is unlikely, based on the current rate of escapement, that the lower value (5,000) of the escapement goal for Buskin River Sockeye Salmon will be achieved.

The commercial and sport fisheries targeting Buskin River origin Sockeye Salmon in this area are also being closed by the ADF&G (Emergency Order #4-FS-K-Sub-02-23)

In an effort to conserve Buskin River Sockeye Salmon, and in concurrence with ADF&G, the Federal public waters of Womans (Womens) Bay are being closed to fishing for Sockeye Salmon for all users.

REGULATION: 36 CFR 242.27(e)(9) and 50 CFR 100.27(e)(9) are amended to add:

(x) Federal public waters of Chiniak Bay west of a line from Cliff Point (57° 43.51' N. latitude, 152° 26.60' W. longitude) to a point near Gibson Cove (57° 46.62' N. latitude, 152° 26.80' W. longitude) are closed to the take of Sockeye Salmon by all users; effective from 12:01 a.m.

Saturday, June 17 to 12:01 a.m. Saturday, July 15, unless superseded by a subsequent Federal special action.

JUSTIFICATION: As of June 13th, approximately 276 Sockeye Salmon have migrated upstream past the ADF&G Buskin weir counting station, while the desired escapement target is a range from 5000 to 8000 fish. It is unlikely, based upon the current rate of escapement, that the lower range of the escapement goal for Buskin Lake Sockeye Salmon (5,000) will be achieved. The Kodiak Area Federal Subsistence In-season Manager has determined this closure is warranted under Title VIII of the Alaska National Interest Lands Conservation Act (ANILCA). Closing the identified marine waters under Federal subsistence fisheries jurisdiction to Sockeye Salmon fishing is necessary to protect the few Sockeye Salmon potentially migrating to the Buskin River. The 2023 Buskin River Sockeye Salmon return is critically low and likely cannot withstand any harvest within the defined area.

In an effort to conserve Buskin Lake Sockeye Salmon, the ADF&G has prohibited commercial, sport and subsistence salmon harvest in the marine waters adjacent to the Buskin River drainage. In response to the low level of salmon escapement, ADF&G has also closed the Sockeye Salmon sport fishery in the Buskin River drainage. Collectively, these Federal and State fishery management actions will ensure that Sockeye Salmon approaching and entering the Buskin River drainage have sufficient opportunity to reach their spawning grounds.

ADF&G will continue to monitor Sockeye Salmon escapement into Buskin River on a daily basis. The Federally managed subsistence fishery for Sockeye Salmon may be re-opened before the expiration of this emergency special action should Sockeye Salmon counts increase enough to ensure achievement of the escapement goal.
