Overarching Goals of the Initiative

Reduce user conflicts by:

- Promoting understanding and tolerance for different cultural hunting values
- 2. Encouraging respect for the resource, land, and fellow users in the field
- 3. Reducing meat spoilage and waste

Pilot Project 1: Community Hunter Liaisons

Goal:

 Facilitate direct communication between local community representatives and non-local hunters; inform non-local hunters of meat donation options and cultural values/practices

Achievements:

- Hunter Liaison Positions active in Fort Yukon and Circle 2018-2022
- Funding provided by Yukon Flats NWR with help from Arctic NWR and Yukon-Charley Rivers NP through an annual funding agreement with Council of Athabascan Tribal Governments (CATG)
- Increased engagement between local representatives and non-local hunters; information sharing and gathering

Pilot Project 1: Community Hunter Liaisons

Desired next steps:

- Continue to fund current Community Hunter Liaison positions
- Evaluate Community Hunter Liaison project and explore expansion of project into other areas of the region



Pilot Project 2: Hunt Like An Alaskan

Goal:

 Engage directly with military personnel new to Alaska at bases in the Eastern Interior region (Fort Wainwright and Eielson) to promote safe and ethical hunting practices

Achievements:

- Two working group meetings in 2019
- Eielson and Ft. Wainwright representatives helped identify potential opportunities for outreach with military personnel
- Unfortunately, OSM staff changes and then the COVID-19 stalled progress

Pilot Project 2: Hunt Like An Alaskan

Desired next steps:

- 1. Refine the pilot project "Hunt Like an Alaskan" hunter ethics outreach strategy
- Develop and distribute "Hunt Like and Alaskan" printed and video outreach products
- 3. Hold outreach events on Fort Wainwright Army and Eielson Air Force bases
