

Under Part B of the Individuals with Disabilities Education Act (IDEA) and the public participation requirements of the Part B Regulations at 34 CFR §300.148 and §300.284, a state must provide the general public with an opportunity to comment on policies, plans, and procedures related to the provisions of IDEA and its implementing Regulations.

In compliance with the above requirement, the Marshall Islands Ministry of Education (MOE) and Public School System (PSS) announce the following:

*The sixty (60) days public review period of the Marshall Islands Part B Application for FFY 2016 will begin on February 19, 2016 and continue until April 20, 2016.*

In order to effectively solicit comments from the public, the Ministry of Education has made
