\*The total number of individuals is the unique number of individuals the Program issued offers to. Therefore, the total does not equal the sum of the number of individuals per location. For example, if an individual owns land and receives an offer at two locations, he or she is counted only once in the total.

\*\*This figure is calculated by dividing the number of individuals who accepted offers by the total number of individuals.

†This figure is calculated based on the dollar value of offers. If an individual receives two offers (e.g., one for \$200 and another for \$100) and decides to sell the fractional interests in the \$100 offer, the Program tracks \$300 in offers made and \$100 in amount accepted.

‡This figure is calculated by dividing the dollar amount accepted by the dollar amount offered.
