## Report of DOI Conference Activities and Spending – Fiscal Year 2016

The Department of the Interior (Department or DOI) has implemented effective internal controls over conference spending and activities.

Departmental policies provide a framework of internal controls designed to mitigate risks associated with conference planning, hosting and spending, and ensure compliance with Federal Travel Regulations. The current policy incorporates new guidance for submitting reports on large conferences and summary reports on conference spending over \$20,000 to the DOI Office of Inspector General consistent with statutory guidance contained in the *Consolidated Appropriations Act*, 2014.

For Fiscal Year 2016, DOI complied with the Administration's limitation on agency-sponsored conferences with net expenses in excess of \$500,000, and based on exceptional circumstances, the Secretary granted one waiver in Fiscal Year 2016. The waiver allowed DOI scientists to attend the 2015 American Geophysical Union Fall Meeting, held from December 14-18, 2015.

## Reporting of conferences held during Fiscal Year 2016 that exceeded \$100,000 in net costs.

During Fiscal Year 2016, the DOI conducted 12 conferences in which expenses exceeded \$100,000. Below, please find a listing of these conferences to include costs, date, location of conferences, and other pertinent data.

inspection program with new inspectors and supervisory inspector positions.

**Explanation:** This event was a core component of the NPS A Call to Action plan with a goal of conducting BioDiscovery activities in 100 parks, including five urban parks, which lead to the discovery of species new to science and to the parks. A BioDiscovery event, often referred to as a "BioBlitz," is a 24-hour event in which teams of Federal, state and National Geographic Society scientists, volunteers, and community members, join forces to discover, identify, and learn about as many local plant and animal species as possible within a park unit. The event also hosts young professionals who gain knowledge and experience from the work and benefit from participation and interaction with scientists and others.

This event was an all-inclusive conference that replaced multiple program specific conferences typically held throughout the year.
