# JEMFAC 2009-1 Sustainability of Sector Budgets JEMFAC 2009-2 Operational and Capital Requirements Planning for RMI Utilities JEMFAC 2009-3 Performance-Based Management JEMFAC 2009-4 Compact Funding for the Majuro Hospital Redevelopment Project

#### Resolution JEMFAC 2009-1

Sector Grant Allocations:

Sustainability of Sector Budgets

JEMFAC resolves that the RMI Government develop a plan for managing annual decreases in Compact direct assistance and/or general fund support, and use those plans as the basis for Fiscal Year 2012 budget decisions. The plan should include an evaluation of the ability of the health and education sectors to fulfill their strategic outcomes in fiscal years 2012-2014.

JEMFAC further resolves that the RMI submit its findings and plan through the Office of Insular Affairs to JEMFAC no later than August 1, 2010, and demonstrate it has used the findings and plan as part of its internal budget development process for Fiscal Year 2012.

#### Resolution JEMFAC 2009-2

Operational and Capital Requirements Planning for RMI Utilities

JEMFAC resolves that a concerted multilateral effort be undertaken in order to assist the Government of the Republic of the Marshall Islands in identifying potential funding opportunities to upgrade power generation and distribution capabilities in the RMI and to identify alternate energy opportunities.

JEMFAC further resolves that a review of existing management capacity and rate structures, and implementation of the results of such a review are necessary to ensure that opportunities for improvement of power generation and distribution capabilities are maximized.

Therefore, JEMFAC further resolves that the Office of Insular Affairs, shall organize a meeting, no later than March 31, 2010, of multilateral partners, including, but not limited to the Government of the RMI, the U.S. Department of the Interior, the U.S. Agency for International Development, the Pacific Power Association, the Asian Development Bank, and Rural Utilities Services, to:

- Review power generation and distribution capacity within the RMI;
- Identify funding resources for power generation and distribution capacity;
- Identify alternate energy opportunities;
- Review current utility pricing structures and identify rate structures required to operate on sound commercial principles; and
- Identify opportunities for improving management capacity.

#### Resolution JEMFAC 2009-3

Performance-Based Management

JEMFAC resolves that the Government of the RMI should refocus the performance budgeting effort on the three Compact-funded entities for Fiscal Years 2010 and 2011, to: (1) resolve performance budgeting and measurement issues fully and (2) ensure that the Ministries demonstrate improvements in handling budgets, data, and strengthening the link between both.

#### Resolution JEMFAC 2009-4

Majuro Hospital Redevelopment Project

JEMFAC resolves that it is prepared, in principle, to consider a multi-year commitment of Compact Public Sector Infrastructure Sector funding to support the RMI's efforts to obtain financing necessary for the construction of the Majuro Hospital Redevelopment Project.

JEMFAC further resolves that the RMI will submit a full project description and proposed financing terms to the JEMFAC for its consideration no later than September 30, 2010.

#### Resolution JEMFAC 2009-5

#### **Special Grant Terms and Conditions**

JEMFAC resolves that the following special grant terms and conditions are to be added to

the Fiscal Year 2010 Sector Grants:

#### Education

That the Government of the Republic of the Marshall Islands, through its Ministry of Education, contract outside expertise to develop comprehensive technology plans, including standards for students, teachers and administrators and budget and training schedules to meet those standards. JEMFAC encourages the Office of Insular Affairs to seek unexpended Supplemental Education Grant monies from Fiscal Years 2005 and 2006 to fund the plans.

#### Health

That the Government of the Republic of the Marshall Islands, through its Ministry of Health, undertake a systematic program in Fiscal Year 2010 to diagnose health data problems and discrepancies in the production of statistics using technical assistance from the United Nations Family Planning Agency (UNFPA). The Ministry of Health report at the mid-term technical meeting of JEMFAC on: (1) progress made to complete the diagnostic activity; (2) interim recommendations; and (3) a tentative timetable and list of resources to implement solutions, including any necessary training of line and managerial staff. If the Office of Insular Affairs deems insufficient progress has been made, after appropriate consultations with the Ministry of Health, then JEMFAC may direct the Ministry of Health to undertake additional remedies at its August 2010 meeting.

#### Resolution JEMFAC 2009-6

Fiscal Year 2010 Grant Funding Allocations

JEMFAC resolves that the following amounts are approved for use of Fiscal Year 2010 Compact of Free Association grant funding, subject to the terms and conditions of Resolution JEMFAC 2009-5:
