## Pool of Lands for Road Construction, Operation, and Maintenance \*

Encompassing and beginning at the intersection of Outpost Road and the Izembek National Wildlife Refuge Boundary within the NE1/4SE1/4 of Section 10, Township 57 South, Range 89 West, Seward Meridian, Alaska, being approximately 3,530' Northeast of the intersection of Outpost Road and Outer Marker Road.

Thence leaving the Izembek National Wildlife Refuge Boundary in a Northeasterly direction through the portions of the following sections;
