## Special Presentation from outside group: The Wilderness Society

- This office of the Wilderness Society works on energy issues related to BLM out of their Denver office.
- They are presenting 3 ideas around issues brought up in the past by GAO: Leasing low potential lands, lease suspension, and oil and gas bonding.
- Oil and gas bonding
  - o Issue: the cost of the bond is so low that performance is at risk
  - o It does not reflect the complexity of development today and for inflation.
  - o Proposed solution: adjust the bonding amounts appropriately.
- Leasing low potential lands
  - o Issue: these lands have low competition and are leased without competition. This incurs cost by BLM to offer these leases with little compensation.
  - o Proposed solution: Limit leasing in low competition areas
  - When low potential land is offered for leasing it keeps it from other uses. Increasing the minimum bid would reduce this problem.
  - BLM comment: These leases make it to a lease sale based on expressed interest
    by industry, and the current view point is that if industry is willing to put dollars
    on the table then BLM will lease.
- Lease suspension
  - o Issue: There is little direction for how or when leases are placed in suspension, many of these leases can sit in suspension for a decade or more, currently there are 3 million acres in suspension.
