WORKING GROUP RECOMMENDATIONS:

Non-Fossil

- Provided an overview of the recommendations and highlighted the various goals:
 - With recommendation regarding the Instruction Memo to clarify solar energy right-ofway (ROW) acreage rent schedules, megawatt (MW) capacity fees, lease and grant renewal processes, bond requirements, and application priority for projects in the six southwestern states subject to BLM's Western Solar Plan, goal is to make federal lands as competitive as private lands.
 - With recommendation regarding the wind leasing program, the goal is to bring at least two gigawatts annually through at least 4 annual lease sales on the United States Outer Continental Shelf of at least 500 megawatts each.
 - With recommendation for Secretary to request expansion of the Outer Continental Shelf Lands Act (OCSLA) to the United States Territories, the goal is to raise the profile of this issue.
 - With recommendation to grandfather projects that were under construction or development at the time the BLM issued its "Competitive Processes, Terms, and Conditions for Leasing Public Lands for Solar and Wind Energy Development and Technical Changes and Corrections" (81 Fed. Reg. 92122 (December 19, 2016)), the goal is to promote fairness and equity.

Coal - Matthew

Onshore
