# **WOLF HUNTING SEASON DELAYED IN UNIT 2**

# **EXPLANATION:**

This Emergency Special Action delays the start of the Unit 2 wolf hunting season until October 31.

**REGULATION:** 36 CFR §242.26(n)(2) and 50 CFR §100.26(n)(2) are amended to read:

**Unit 2 – Wolf Hunting** 

No limit. Sep. 1 Oct. 31-Mar. 31.

Any wolf taken in Unit 2 must be sealed within 30 days of the end of the season.

# **JUSTIFICATION:**

An Emergency Wildlife Special Action Request was received from Alaskans FOR Wildlife and requested changing the opening date of the wolf hunting season in Unit 2 from Sept. 1 to Nov. 1. The proponent requests delaying the opening of the Unit 2 wolf hunting season to allow time for the 2019 population estimate to become available. The proponent understands this estimate should be available prior to the start of the State and Federal trapping seasons, and believes that any wolf harvest should be prohibited until such information is available to inform sound management decisions.

From 2015-2019, the Unit 2 wolf population estimates have become available between late August and early October, depending on the year. The Alaska Department of Fish and Game (ADF&G) expected that the lab analyzing the DNA samples would submit their results to ADF&G by July 2020; however social distancing practices delayed their work. Therefore, ADF&G does not expect to have a population estimate before mid-late September.

The new harvest management strategy adopted by the Federal Subsistence Board and the Alaska Board of Game relies on population estimates to set season lengths. If the population estimate is below 100 wolves, no season will be announced. The Covid 19 virus has led to delays in processing the genetic samples used to produce the population estimate. Lack of a population estimate requires a cautious approach to wolf management given the high wolf harvest in 2019. While this closure will impact subsistence users, historically very few wolves are harvested during this time. Once the population estimate is available and harvest is determined to be allowed under the plan, the season may reopen before October 31 through subsequent special action.
