

**2015 Yukon River Fall Salmon Fishery News Release # 26
Fall Announcement # 24, Yukon River Subdistricts 5-B and 5-C Commercial Period 2**
Districts Affected: Upper Yukon Area

The 2015 fall chum salmon preseason run projection, based on inseason run assessment is for a run size between 700,000 and 800,000 fish. This level of abundance should be sufficient to provide for escapement, an above average subsistence harvest, and a surplus available for commercial and personal use purposes. The estimated fall chum salmon passage at the mainstem sonar near Pilot Station through August 16 is 396,800 fish, which is above the historical median of 360,700 fish for that date.

Subdistricts 5-B and 5-C Commercial Schedule:

In Subdistricts 5-B and 5-C, commercial fishing will be open for one 5-day fishing period from 6:00 p.m. Tuesday, August 18, until 6:00 p.m. Sunday, August 23. Gillnets will be restricted to six-inch or smaller mesh size. Verbal reports from the August 11 through August 16 commercial opening indicate a preliminary harvest of 516 fall chum salmon. The cumulative commercial harvest through August 16 is 516 fall chum salmon.

Commercial fishermen must confirm their market prior to commercial fishing. Processors, catcher sellers, or direct marketers should notify the department of their intent to operate by contacting the Fairbanks office at 459-7274.

This commercial period will be open concurrently with subsistence salmon fishing.

Subdistricts 5-B and 5-C Subsistence Fishing Schedule:

Subsistence fishing is open 24 hours per day, seven days per week with fish wheels or gillnets with a mesh size of 7.5 inches or smaller. Subsistence fishermen are reminded that a fishing permit is required to fish for all species in the portion of Subdistricts 5-C from the western most tip of Garnet Island upstream to the mouth of Dall River. Subsistence fishermen outside of the permit area are encouraged to fill out their subsistence salmon catch calendars. Calendars and subsistence fishing permits are available from the Alaska Department of Fish and Game in Fairbanks.
